



**Exclusive Summer Guiding Companies
Wells Gray Provincial Park**

BC Parks does not require guiding companies to have a permit if they are stopping at short term day-use spots in the corridor. Following are the listed Day Use locations where a commercial company may stop with their clients **without a Park Use Permit: Spahats Falls** (viewing platform and Shaden), **Green Mountain Viewing Tower**, **Majerus Hut**, **Dawson Falls**, **Helmcken Falls**, **Red Spring**, **Ray Farm** (to farm meadow only), and **Bailey’s Chute** (to viewing Platform only). Commercially guiding clients in all other areas in Wells Gray Provincial Park requires a valid Park Use permit.

In 2003 BC Parks initiated an exclusive proposal call opportunity that eventually awarded six (6) seasonal(spring-fall), multi-year permits for guided hiking and canoeing (10 year permits). No further commercial Guiding permits will be issued for these activities, therefore any activities that your company would like to participate in within the park, including guided hiking or guided canoeing, would require either an accredited guide from these listed companies, or some form of written agreement with one of these companies.

There are three companies that can provide only day guiding opportunities, and three that can offer both day and overnight guiding opportunities within Wells Gray Provincial Park. Please feel free to contact any or all of these companies to negotiate an arrangement that could best suit your needs.
