SANDWELL PROVINCIAL PARK Purpose Statement and Zoning Plan

Primary Role

The **primary** role of Sandwell Provincial Park is to protect natural and cultural features and values. The park contains a number of archaeological sites, petroglyphs and middens.

The park contains a long, sandy beach and forested upland on the north side of Gabriola Island facing the Strait of Georgia. A saltwater marsh on an adjacent property is a red-listed plant community with high ecological values.

Secondary Role

The **secondary** role of the park is to provide recreational opportunities associated with the natural values of the park. The park offers a variety of day use activities including picnicking, beach combing, swimming, strolling and nature viewing. A steep trail provides access for local residents and visitors to Gabriola Island down to the long sandy beach with an adjacent natural grass and marsh upland that is privately owned.

Known Management Issues	Response
Future development on adjacent private lands and impact on sensitive salt water marsh ecosystem which is not part of the park.	Discuss with Nanaimo Regional District protective zoning options and/or with private land owners on future acquisition/donation of salt water marsh lands for addition to park.
Poor trail access due to steep terrain may cause safety hazards.	Addition of salt water marsh lands would conserve a sensitive habitat and improve access to park.
Blowdowns from adjacent properties on ridge above park.	Discuss with neighbours strategies about minimizing impact on park as trees and debris fall into the park after wind storms.
Improved maintenance of park facilities required. Vandalism is a problem.	Promote local resident volunteer Park Watch program to help protect park's cultural and natural values.

Zoning

Natural Environment Zone includes forested upland and marine foreshore (approximately 84% of the park). The Special Feature Zone includes known archaeological sites, sensitive shoreline and intertidal habitat (approximately 16% of the park).

Conservation

- Representation
- ecosection Contributes minimally (0.11% of overall ecosection representation) to the representation of the Southern Gulf Islands Ecosection, of which 5.6% is protected in the protected areas system. The marine foreshore (containing 9 hectares) protects the intertidal and marine habitats.
- biogeoclimatic subzone/variant CDFmm biogeoclimatic variant which is poorly represented (2.43%) in the system; Sandwell Park contributes only 0.04% of the overall representation of the CDFmm.
- Special Feature Provides public access to a long sandy, gravel beach which provides habitat for migrating shorebirds.
- Rare/Endangered Values Unknown




Zoning Map - Sandwell Provincial Park
