QUARTERLY COMPLIANCE AND ENFORCEMENT SUMMARY

April 1, 2009 to June 30, 2009

The 2nd Quarterly Compliance and Enforcement Summary for 2009 outlines six Orders, 22 Administrative Sanctions, 359 Tickets and eight Court Convictions for a combined total of over \$600,000 in fines.

Notable highlights this Quarter:

Canadian National Railway Company (CN) pleaded guilty to one count under the Federal *Fisheries Act* in relation to the derailment of a CN train into the Cheakamus River in August 2005. CN was fined \$50,000 and ordered to pay \$350,000 to promote the conservation of fish habitat in the Squamish watershed. The derailment caused a release of 45,000 litres of sodium hydroxide spilling into the river, killing approximately half a million fish.

West Fraser pleaded guilty to one count of depositing a deleterious substance to water frequented by fish. The court fined West Fraser \$5,000 and ordered payment of \$65,000 to the University of Northern British Columbia and \$60,000 to the Habitat Conservation Trust Foundation for the purposes of conservation and protection of fish and fish habitat. The investigation revealed that West Fraser had not been duly diligent in the maintenance of the Eurocan Pulpmill's effluent treatment system, resulting in the spill of untreated effluent into a tributary of the Kitimat River.

Walker Rook Addison was convicted on five counts under the *Wildlife Act* for illegal hunting activities in a residential neighbourhood in Nanaimo. The sentencing for this case has been held over to the fall of 2009, and will be reported when the information is available. Addison was also convicted in 2008 on four counts under the *Wildlife Act* connected to an illegal hunt in the Kootenays.

Brentwood Bay resident **James Murray Sampson** was convicted on four counts under the *Wildlife Act* for illegally trafficking eagle parts. Sampson was sentenced to 12 days in jail, fined \$650 and ordered to do 60 hours of community service. The BC Conservation Officer Service, RCMP and policing agencies from other jurisdictions of Canada and the United States have been working cooperatively on a large-scale investigation into the illegal trade of rare bird parts. To date, the courts have convicted 8 of 15 individuals charged in this investigation, resulting in a total of over \$53,000 in penalties. The remaining seven individuals still remain before the courts and we will report those results as they become available.

The operators were ordered to: (1) immediately cease the deposit of additional red meat waste to the compost, and; (2) within 30 days consolidate the refuse and landfill the material on the property in trenches no more than 2 meters wide, at least 50 meters from the property line, at least 100 meters from any surface water, 300 meters from any residence, water supply or water intake, and ensure all waste is immediately covered with at least 1.8 meters of soil.

The proximity to a school yard and residential area made the operation of the improperly functioning boiler not possible without causing pollution and harming human health and the environment.
Downie RV Resorts Ltd.	Revelstoke	<i>Water Act</i>		88	An Engineer's Order was issued to the resort owner after construction activities posed a risk of damaging fish and fish habitat. To mitigate potential for environmental damage during the spring freshet, the ministry ordered that work be done immediately to: (1) remove trees placed on a natural log jam; (2) place boulders in the intake channel to reduce the possibility of a breach at this location, and; (4) all materials and equipment used for the project completion shall be operated and stored in such a manner that prevents any deleterious substances (e.g. petroleum products, silt, etc.) from entering the water.
