CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is Lone Tree Creek and the reservoir is Uk Lake.
- (b) The points of diversion are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 5th August, 1965.
- (d) The purpose for which this licence is issued is storage.
- (e) The maximum quantity of water which may be diverted for storage is 145 acre feet per annum.
- (f) The period of the year during which the water may be diverted into storage is 1st October to 15th June.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is as set out in Conditional Water Licence 122011.
- (h) The authorized works are diversion structure, ditch and dam which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December 2009. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- (j) This licence is issued pursuant to the provisions of the Water Act to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.
- (k) Construction or reconstruction of the dam shall not be commenced until plans prepared by a professional engineer registered in British Columbia have been submitted to and written leave to commence construction granted by a Dam Safety Officer under the Water Act.
- (l) This licence is issued in substitution of Conditional Water Licence 32054.

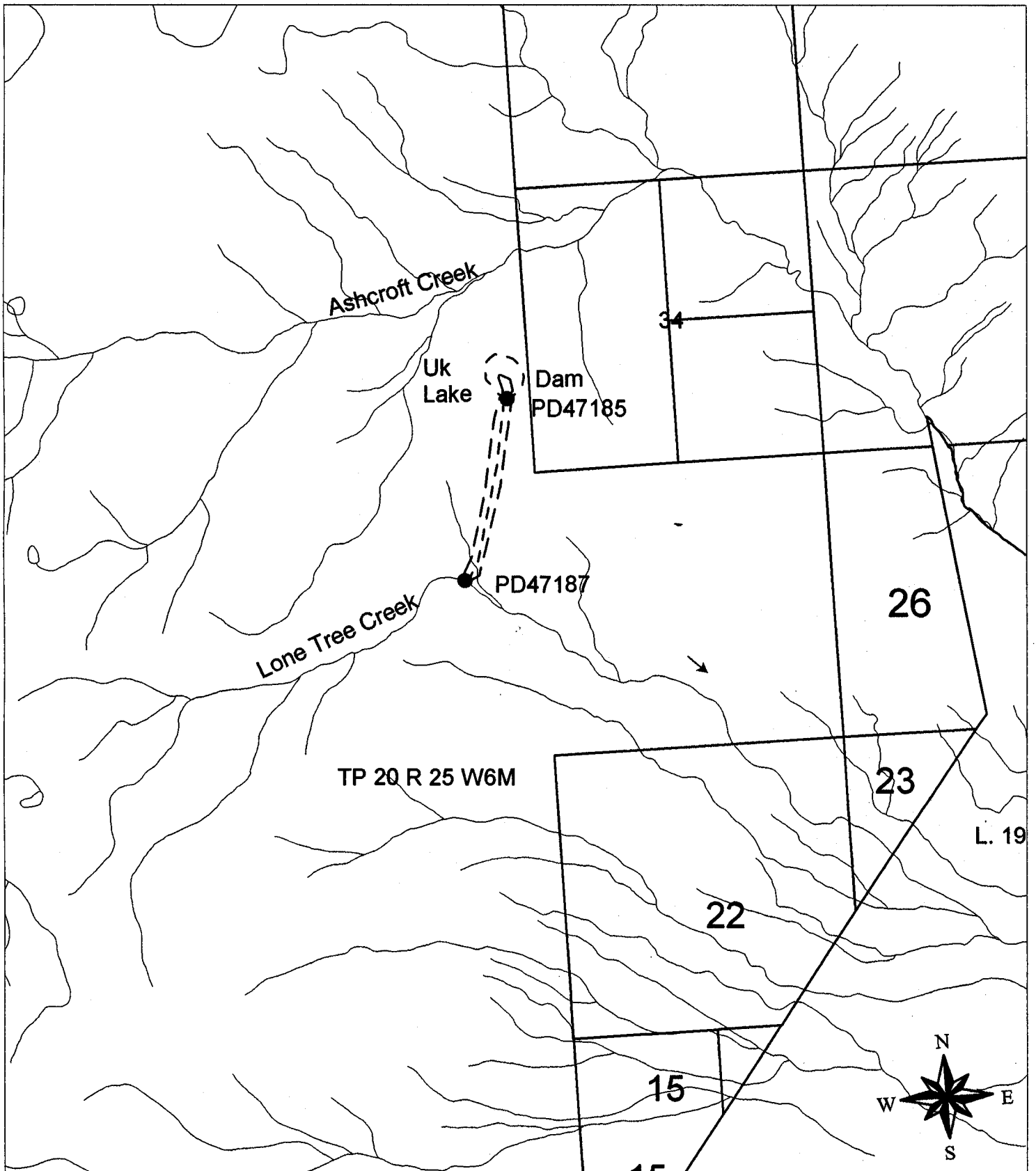
