Recall and Re-issue of the Certificate of Incorporation
of the Campbell Creek Water Users' Community

File No. 0128982

The Certificate of Incorporation of the Campbell Creek Water Users' Community issued by the Deputy Comptroller of Water rights on the 1st day of February, 1983, and any amendments thereto, are hereby recalled and the following issued in lieu thereof:

This is to certify that the holders of water licences who share a common interest in water licences authorizing the storage of water within Trapp, Shumway, Campbell and Scuitto lakes and hold water licences authorizing the diversion and use of water from Campbell Creek, are hereby incorporated into a Water Users' Community as follows:

- 1) The name of the Water Users' Community shall be Campbell Creek.
- 2) The Water Users' Community is incorporated for the purposes of construction, maintenance and operation of dams on Trapp, Shumway, Campbell and Scuitto Lakes, and in respect to the following storage licences, is given all the powers set out in Section 53 of the Water Act:


