**Amendment of the Certificate of Incorporation**

WHEREAS the Campbell Creek Water Users' Community (the "Community") is incorporated to undertake the storage and release of water to supply its members; and

WHEREAS water licences have been issued that are supported by storage provided by the Community and where the right to divert and use water is exercisable only during such times as the licensee remains a member of the Community; and

WHEREAS I am satisfied the holders of those licences have met their obligations to become members of the Community.

I HEREBY amend Schedule "A" of the Certificate of Incorporation of the Community, issued by the Deputy Comptroller of Water Rights on July 12, 2005 to include the following licences within the membership of the Community:
