#### **Brought Forward Action Items** (last RAWC minutes on screen)

### Item #1 Donna

Park the Wildlife Act amendment for now, but work at Regulation amendment to use shotguns and slugs for elk in specific locations by permit. *In progress*.

### Item #2 Andy McDonald?

Initiatives Program for funding but he hasn't heard back yet on their success (and he hasn't submitted any receipts or received any money either!).

## Item #3 Brian Huscroft?

To check with the Creston Agricultural Society if they want a representative from the vine or orchard fruit or crop sectors on the RAWC. *In progress. Donna to pester Brian and then follow up with the Creston Agr'l Society.* 

# Meeting Notes, New Action Items & Agreements

- 1. Discussion on AGRI and AWP compensation payments, still need more grass in EK as AGRI of the provincial government cannot continue to pay money for crop depredation forever. Peace, Cariboo and EK are 3 major areas for payments.
- 2. Brian Huscroft recommended Creston bow season to be all month, not just 20 days in December, for either sex Whitetail. James Barber commented on orchards in Creston being hit hard by wildlife this year and wanted WHT season to go to end of January. Also to expand the LEH boundary. After further discussion, want either sex whitetail in all of Region 4 to go to end of December. Also a GOS for Whitetail. Action Item Donna to suggest season extension to HQ and to chat with Garth, Mike and Leo again about moving LEH boundary in Corn and Dodge Creeks.
- **3.** A 'disabled hunter' season, either alone or combined with the Youth/Senior season, is not possible with the present perspective of HQ. **Action Item -** *Donna to write a proposal for a pilot project under a permit in the EK and approach Paul Rasmussen? Jeff Morgan to research the current F&W Policy and Procedures. Robert McKeeman to review what Montana does.*
- **4.** Report to RAWC on the 'BC Outdoors Passport' by Gary Glinz, have had a very low uptake so far by the public. No more trespass complaints called in to the COS from the 2011 GOS in Creston but Cranbrook had a few issues. **Action Item -** *Gary will write another article for the 'Outdoor Edge' magazine*.
- **5.** KLEP final report. **Action Item** *In progress. Jeff has received numbers from Faye and Tara.*
- **6.** Discussion on ways to remove more elk, to meet 30% reduction goal of the EMP. Suggested to put the Youth/Senior hunt at the end and the GOS at the beginning (first 7-10 days), to increase hunter success (so that the elk would not be so wary and become nocturnal so quickly?). The Youth could still take advantage of Christmas holidays for hunting. **Action Item** *Donna to check with Tara/Stephen to see if this is possible, or if HQ's hunter recruitment initiative is more important than hunter success?*
- **7.** Discussion on getting an agricultural representative on the KWHAC. RAWC has an EKWA rep, so want as aggie in with the hunting lobby as well. **Action Item** *Donna to contact Dave Dunbar with the request.*
- **8.** Brian Huscroft interested in applying for funding to build moveable hunting blinds. **Action Item** *Donna will help him with developing a proposal to CBT and/or HCTF*.
- 9. Discussion on Kill Permits, they are an available legal tool, but Regional Managers issue them when in-field damage is severe and when ALL other reasonable prevention and or mitigation options have been attempted. In general, if hunting is possible, FLNRO prefers to rely on regulated hunting to address issues with problem wildlife. In areas where the harvest of relatively few individual animals and/or the hazing of herds is required on an ongoing basis, FLNRO can consider the creation of LEH hazing oriented hunts that are intended to move animals away from areas of conflict (these hazing oriented hunts are not designed to significantly reduce wildlife numbers). Action Item Jeff and Donna to complete review to the kill permit procedure (The Management of Problem Wild Ungulates). Action Item Donna to consider the creation of LEH hazing hunts where required in Region 4.
- **10.** Gary Glinz presented a powerpoint show on Hunting Access in the East Kootenays. He'd like the RAWC to form a Road Access subcommittee to look at correcting some of the inaccuracies in the

- Regional District maps, also to try for corporate sponsorship of better signage? Brian Huscroft and Glyn Killins volunteered to help out.
- 11. Nicks Island Dyking District elk fence in Creston was briefly discussed, Brian Huscroft gave summary. He has worked hard to get local landowners to work together on one fence, rather than each farm fencing separately. Action Item No action on fence yet. Delay HCTF application for funding to collar some Creston elk (SW herds), until the Mt. Caribou transplant has been completed (not enough expertise, manpower or telemetry equipment available).
- **12.** Passed out hard copies of the PAZWP-KBR 2011 brochure and the Terms of Reference for the RAWC; both had to be re-written to reflect the government's changes. The TOR had one correction with the distinction between the BCCA's Regional group and their Districts. (Also, one later correction was emailed in, as the COS are still under MOE!)
- **13.** Wrap up and determine date for next meeting, tentatively May, 2012.
