Re: Notice of Continuation and Amendment of a Section 16 Map Reserve

This Reserve that was established on September 26, 2005, under File 4404314, over the Crown land described as all those parcels or tracts of Crown land situated in the vicinity of the Selkirk, Monashee, Columbia and Purcell Mountain Ranges, Kootenay District, containing approximately 927,119.889.0 hectares, more or less for suspending the issuance of any new commercial recreation tenures while the Species at Risk Recovery Coordination Office engages in Mountain Caribou recovery planning purposes; and

This Reserve that was established on October 16, 2007, under File 3411817, over the Crown land described as all that Crown land from Pine Pass to Highway #1 at Revelstoke (Mountain Caribou Species at Risk), containing approximately 1,276,617.00 hectares, more or less for suspending the issuance of any new winter commercial recreation tenures while the Species at Risk Recovery Coordination Office engages in Mountain Caribou recovery planning purposes is hereby amended by removing and replacing within

## THEREFORE:

"The Reserve Area is hereby amended by combining Crown land Files 4404314 and 3411817. Reserve No. R083004 under File 3411817 will now be under Reserve No. R050326 under File 4404314. The reserve now covers all those parcels or tracts of Crown land situated in the vicinity of the Selkirk, Monashee, Columbia and Purcell Mountain Ranges, Kootenay District, and all that Crown land from Pine Pass to Highway #1 at Revelstoke (Mountain Caribou Species at Risk), shown outlined in red on the sketch attached and contains 2,203,736.889 hectares, more or less. The addition is to remain in effect until March 31, 2018, during which applications within the amended area are to be referred to the Ministry for

comment and consideration in the adjudication of such applications, effective today's date.

 The Reserved Area purpose is hereby amended from "the purpose of suspending the issuance of any new winter commercial recreation tenures while the Species at Risk Recovery Coordination Office engages in Mountain Caribou recovery planning" to now read "the purpose of suspending the issuance of any new commercial recreation tenures while the Ministry of Forests, Lands and Natural Resource Operations engages in Mountain Caribou recovery implementation."

All other terms and conditions within Files 4404314 and 3411817 remain the same.

This area is amended providing that prior to conducting any land altering activities or development on the property it will be your responsibility to:

- 1. Resolve any resource agency or land use issues.
- 2. Determine the existence of aboriginal rights, assess whether your proposed activity will infringe upon those rights and to resolve any infringement in accordance with established policies.
- 3. Obtain all necessary permits prior to establishment of any improvements on the land.
