

ORDER

Section 37 Water Sustainability Act

IN THE MATTER OF Final Water Licence 7306 authorizing the diversion and use of 98,678.4 cubic metres per annum for Irrigation: Private purpose for use within part of the Northwest ¹/₄ Section 7 Township 19 Range 17 West of the 6th Meridian Kamloops Division Yale District.

HAVING DETERMINED THAT no other water supply is reasonable available I hereby authorize the use of water authorized under this licence to be used on land, other than the land to which the licence is appurtenant with the terms and conditions set out below:

- 1) The point of diversion is located as shown on the attached plan.
- 2) The maximum quantity of water which may be diverted is 49,340 cubic metres (40 acres feet) per annum.
- 3) The period of the year during which the water may be used is April 1st to September 30th.
- 4) The land upon which the water is to be used and to which this order is appurtenant is Lot 1 Section 8 Township 19 Range 17 West of the 6th Meridian Kamloops Division Yale District Plan EPP46305, of which 16.188 (40 acres) may be irrigated.
- 5) The authorized works are diversion structure, pump, pipe and irrigation system which shall be located approximately as shown on the attached plan.
- 6) This order is issued under the *Water Sustainability Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- 7) The licensee shall install a flow metering or other measuring device to the satisfaction of an Engineer under the *Water Sustainability Act*.
- 8) The licensee shall retain flow meter/measurement records for inspection upon request by an Engineer under the *Water Sustainability Act*.
- 9) No compensation has been requested or made.
- 10) The licence holder must be notified prior to the withdrawal of water under this order.

11) The quantity and duration of water withdrawal must be reported to the licensee within 30 days of use.


This extension of rights expires July 26, 2016.
