FINAL WATER LICENCE.

JACK L. SMITH

of Nicola, B. C.

hereby authorized to divert and use water as follows:—

(a.) The source of the water-supply is Kirby Creek, tributary of Clapperton Creek

(b.) The point of diversion is located as shown on the attached plan.

(c.) The date from which this licence shall have precedence is 16th November, 1940

(d.) The purpose for which the water is to be used is irrigation

(e.) The maximum quantity of water which may be diverted is 13.75 acre-feet per annum

and such additional quantity

as the Engineer may from time to time determine should be allowed for losses.

(f.) The period of the year during which the water may be used is 1st April to 30th September

(g.) The land upon which the water is to be used and to which this licence is appurtenant is 5.5 acres of Lot 1920, Kamloops Division of Yale District

as shown on the attached plan.

(h.) The works for the diversion and carriage of the water are ditches

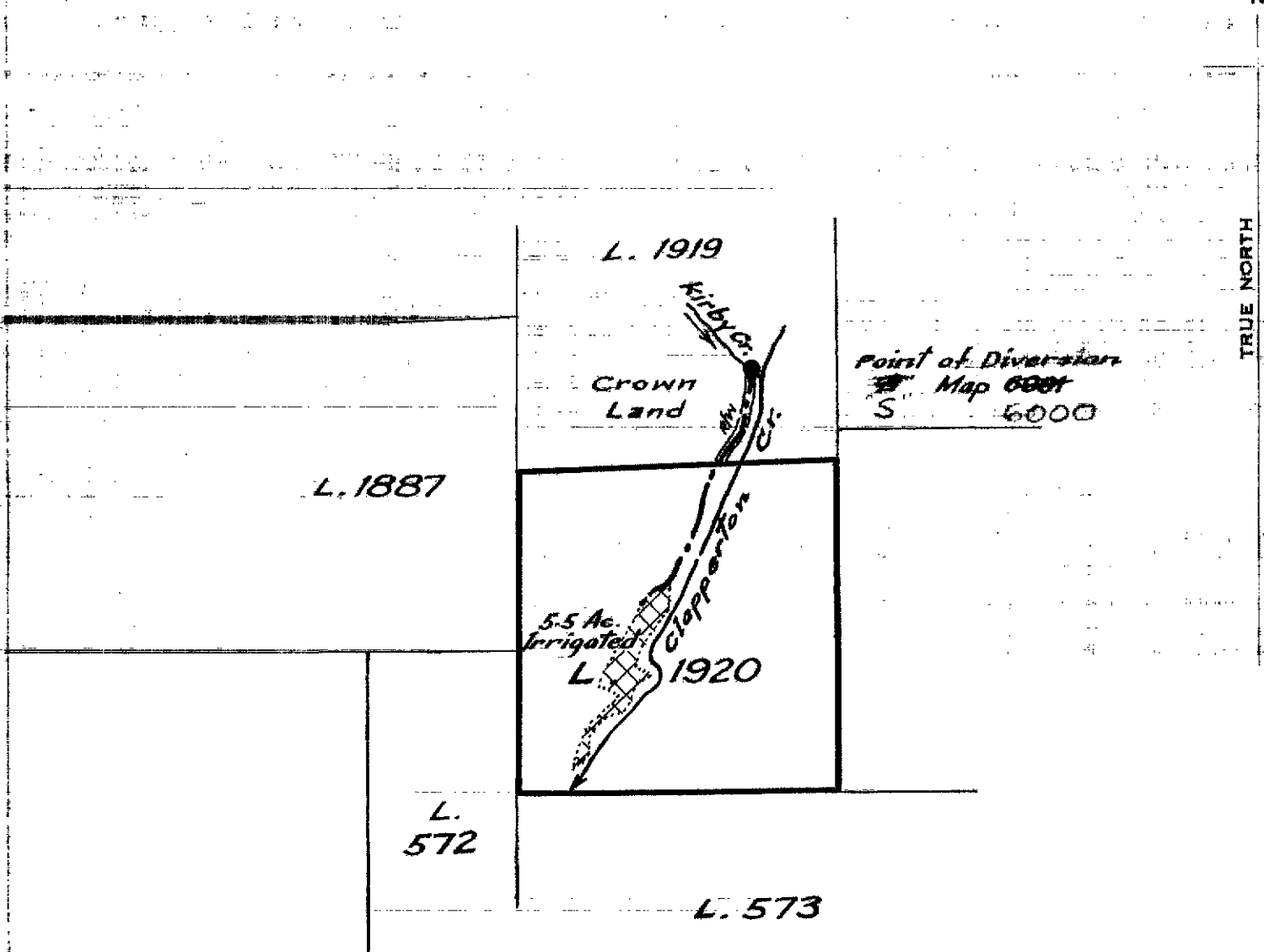

ORDER

WATER ACT

Section 15

File No. 0078834

In the matter of Final Water Licence 11800, which authorizes the diversion of water from Kirby Creek for irrigation purpose.

Having determined that the land upon which the water is to be used and to which said licence is appurtenant has been redescribed, and being satisfied that no persons rights will be injuriously affected, I hereby amend clause (g) of said licence to read as follows:

- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1920, Kamloops Division of Yale District, except Plans 18958 and 27211, of which 5.5 acres may be irrigated.

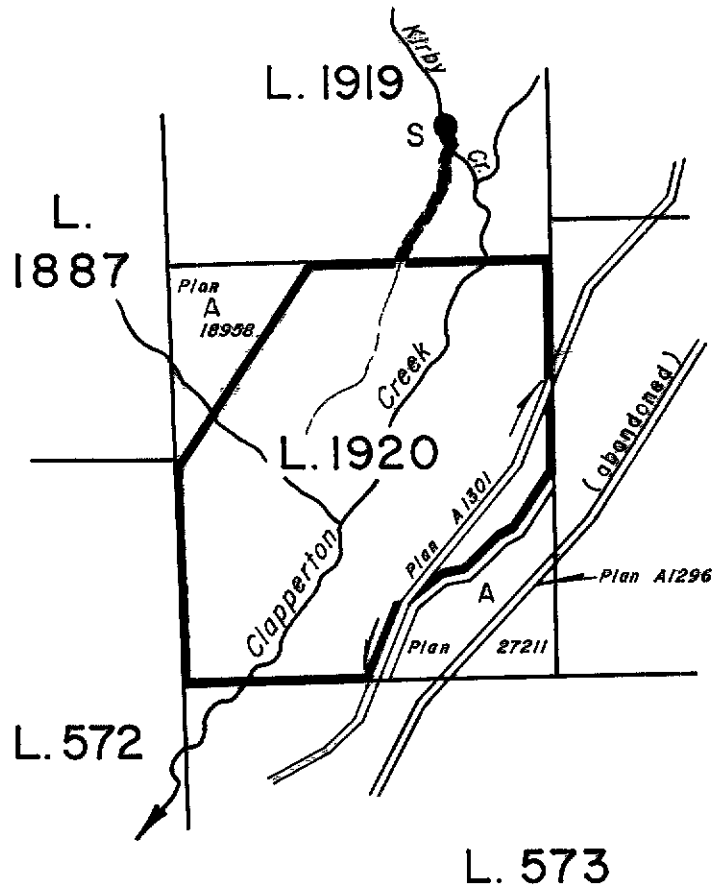
