CONDITIONAL WATER LICENCE.

CHAPMAN & SONS, of Mazama, B. C., are

hereby authorized to divert and use water as follows:—

- (a.) The source of the water-supply is Trout Creek.
- (b.) The point of diversion is located as shown on the attached plan.
- (c.) The date from which this licence shall have precedence is 27th June, 1940.
- (d.) The purpose for which the water is to be used is irrigation.
- (e.) The maximum quantity of water which may be diverted is 50 acre-feet per annum,
and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f.) The period of the year during which the water may be used is 1st April to 30th September.
- (g.) The land upon which the water is to be used and to which this licence is appurtenant is 20 acres of District Lot 2089, Kamloops Division of Yale District,
as shown on the attached plan.
- (h.) The works for the diversion and carriage of the water are ditch and flume,
the construction of which shall be commenced on or before the 30th day of April, 1941, and shall be completed and the water beneficially used on or before the 31st day of December, 1943.

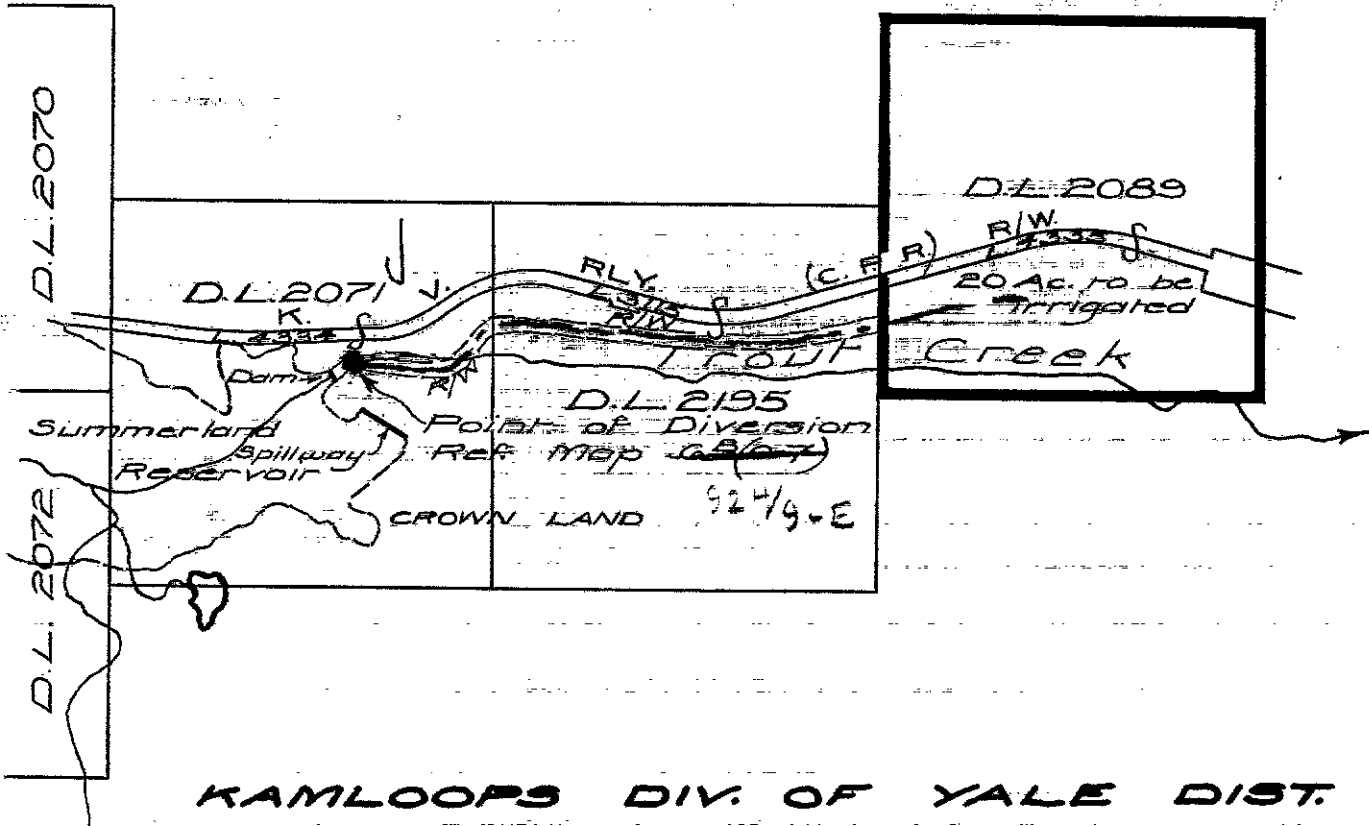
