FINAL WATER LICENCE

WILLIAM McLEAN of Okanagan Falls, B. C. is

hereby authorized to divert and use water as follows:—

- (a) The source of the water-supply is McLean Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 25th July 1887.
- (d) The purpose for which the water is to be used is Irrigation and Domestic.
- (e) The maximum quantity of water which may be diverted for irrigation purpose is 96.25 acre feet per annum and for domestic purpose is 250 gallons a day and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Block C, Registered Plan 1415 Kamloops Land Registration District of District Lot 464, Osoyoos now Similkameen Division of Yale District, of which 38.5 acres may be irrigated.
- (h) The works authorized hereunder are Headgate, Flume and Ditch located as shown on the attached plan.
- (i) This licence is issued in substitution of ~~Conditional~~ ^{Final} Water Licence No. 4332 (in part).
- (j) This licence authorizes the use of water for domestic use in the dwelling on the land described in clause (g) at the date hereof and in any dwelling built to replace the same but not in any other dwelling.

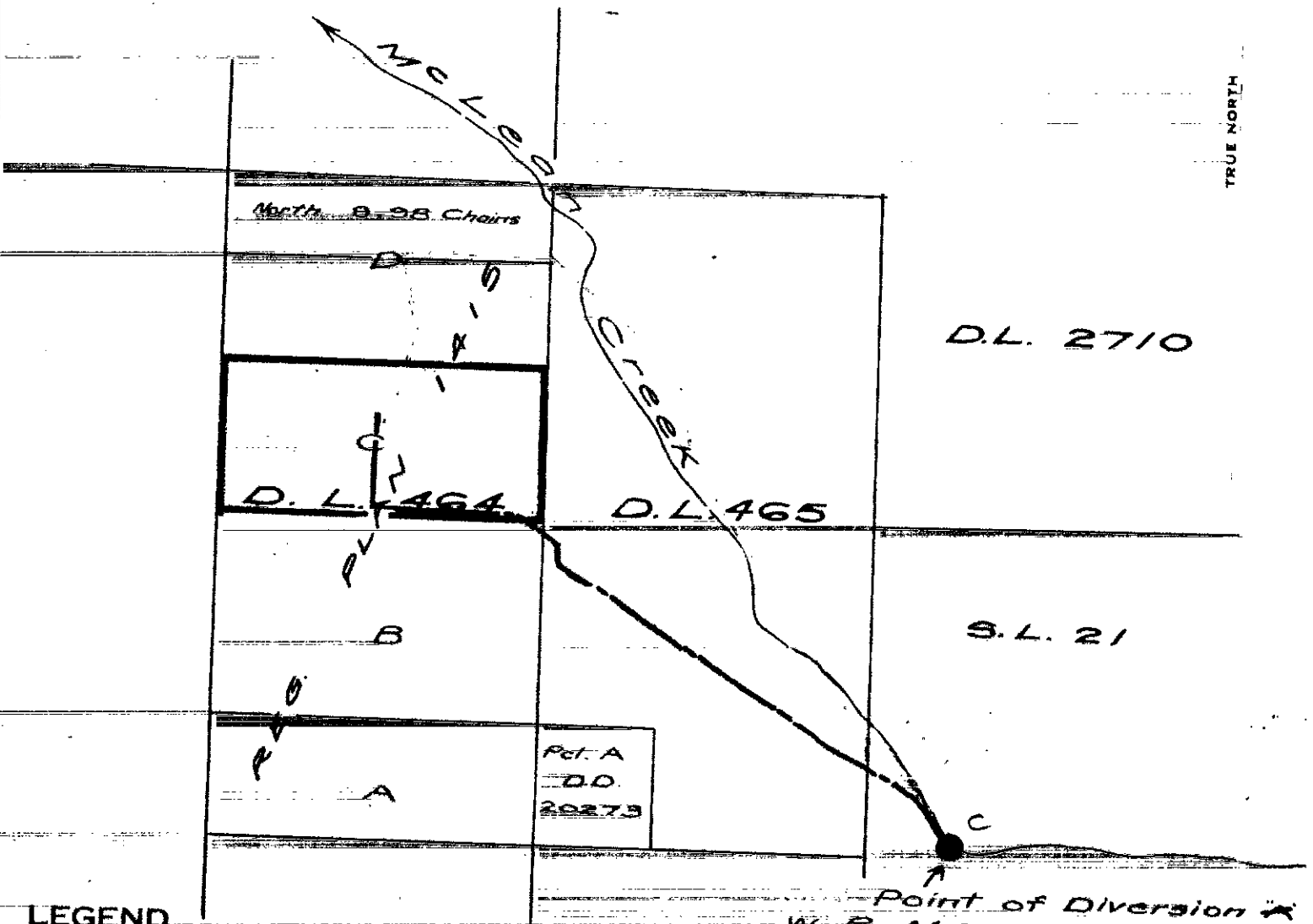

ORDER UNDER THE WATER SUSTAINABILITY ACT
SECTION 26

File No. 8001958

In the matter of Final Water Licence 013798, which authorizes the diversion of water from McLean Creek for irrigation purpose within Lot C District Lot 464 Similkameen Division Yale District Plan 1415, of which 38.5 acres may be irrigated; and,

Having determined that the land upon which the water is to be used and to which said licence is appurtenant has been re-described, and being satisfied that no person's rights will be injuriously affected I hereby amend clause (g) of the said licence to read as follows:

(g) The land upon which the water is to be used and to which this licence is appurtenant is Lot C District Lot 464 Similkameen Division Yale District Plan 1415 except Plan KAP50649; of which 15.58 hectares (38.5 acres) may be irrigated.
