DIRECTOR OF INDIAN AFFAIRS of Ottawa, Canada, is hereby authorized to divert and use water as follows:—

- (a) The source of the water-supply is **Mameet Spring.**
- (b) The point of **diversion** is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is **23rd February, 1948.**
- (d) The purpose for which the water is to be used is **Irrigation.**
- (e) The maximum quantity of water which may be **diverted is 250 acre feet per annum** and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be **used is 1st April to 30th September.**
- (g) The land upon which the water is to be used and to which this licence is appurtenant is **South portion of Indian Reserve No. 1, Nicola Mameet, of which 100 acres may be irrigated.**
- (h) The works authorized to be constructed are **Headgate and Ditches** and they shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be commenced on or before the **30th** day of **June** **1948** and shall be completed and the water beneficially used on or before the **31st** day of **December** **1952.**

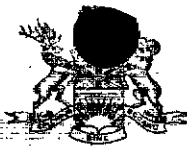

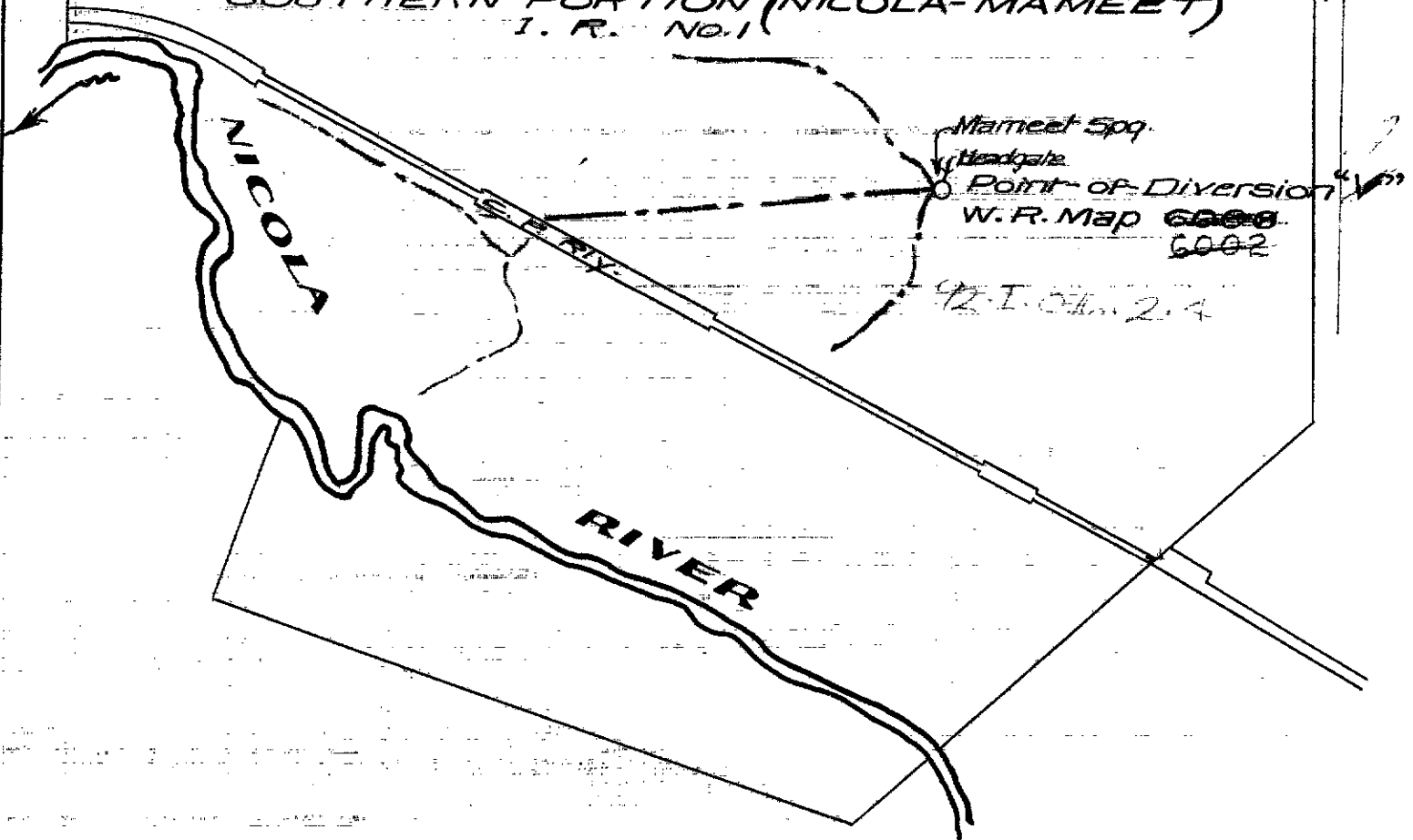
NICOLA WATER DISTRICT.
