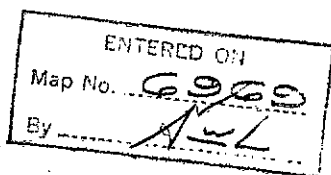

CONDITIONAL WATER LICENCE

HAROLD DENNIS CHARLES ALLISON of Box 21, Princeton, B. C. is

hereby authorized to divert and use water as follows:—

- (a) The source of the water-supply is Summers Creek, tributary of Allison Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 8th June, 1951.
- (d) The purpose for which the water is to be used is Irrigation.
- (e) The maximum quantity of water which may be diverted is 75 acre feet per annum and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 2415, Kamloops Division of Yale District, of which 30 acres may be irrigated.
- (h) The works authorized to be constructed are Pump and Sprinkler System and they shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be commenced on or before the 30th day of June, 19 52, and shall be completed and the water beneficially used on or before the 31st day of December, 19 54.

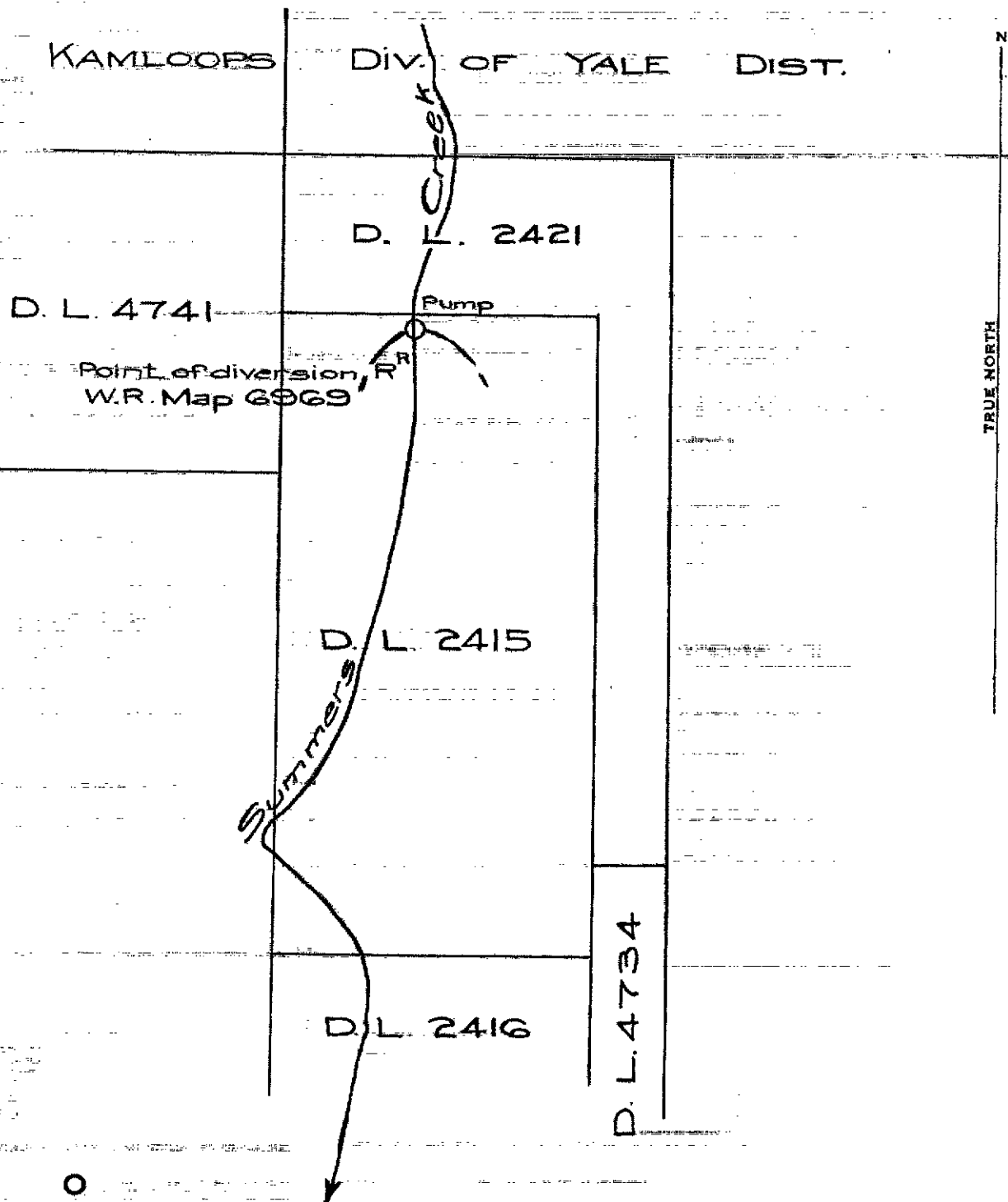
