

In the matter of Conditional Water Licence 29463, which authorizes the diversion of 100 acre feet per annum of water from Hodgkinson Creek for irrigation of 50 acres of Lot 37, Cariboo within Lillooet District and Fractional South East 1/2 of Section 36, Township 42, except Pacific Great Eastern Railway Right of Way and Lots 2258a and 2249, Lillooet District.

Having received an application for Transfer of Appurtenancy from the licensee and being satisfied that no person's rights will be injuriously affected, I hereby amend Clauses (b), (g), (h) and (i) of the said license to read as follows:

- (b) The point of diversion is located as shown on the attached amended plan.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Fractional South East  $\frac{1}{4}$  of Section 36, Township 42 and those parts of Lots 37 and 2249, Cariboo District and Lots 218 and 2258A, Lillooet District, lying south of British Columbia Railway Right of Way (Plan A-130), of which 50 acres may be irrigated.
- (h) The works authorized to be constructed are diversion structure, pipe and sprinkler system, which shall be located approximately as shown on the attached amended plan.
- (i) The construction of the said works has been commenced and shall be completed and the water beneficially used on or before the 31st day of December, 1979.


