

THE PROVINCE OF BRITISH COLUMBIA—WATER ACT

CONDITIONAL WATER LICENCE

Alan and Jean W. McGibbon of R.R.#1, Louis Creek, B.C.

is/are hereby authorized to divert and use water as follows:—

(a) The source(s) of the water-supply is/are Alan Brook.

(b) The point(s) of diversion is/are located as shown on the attached plan.

(c) The date from which this licence shall have precedence is 9th October, 1962.

(d) The purpose for which the water is to be used is domestic.

(e) The maximum quantity of water which may be diverted is 1000 gallons a day,

and such additional quantity
as the Engineer may from time to time determine should be allowed for losses.

(f) The period of the year during which the water may be used is the whole year.

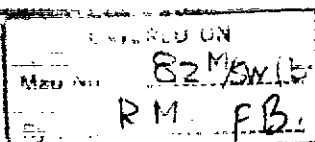
(g) The land upon which the water is to be used and to which this licence is appurtenant is
that part of Special Timber Lease 13220P, Kamloops Division of
Yale District, held under Special Use Permit 1198,


(h) The works authorized to be constructed are intake box, pipe and standpipe,

and they shall be located approximately as shown on the attached plan.

(i) The construction of the said works has been completed and the water shall be
beneficially used on or before the 31st day of December, 1966.

(j) This licence authorizes the use of water in the two buildings
situated on the land described in clause (g) at the date hereof,
or any buildings replacing same but not in any other buildings.

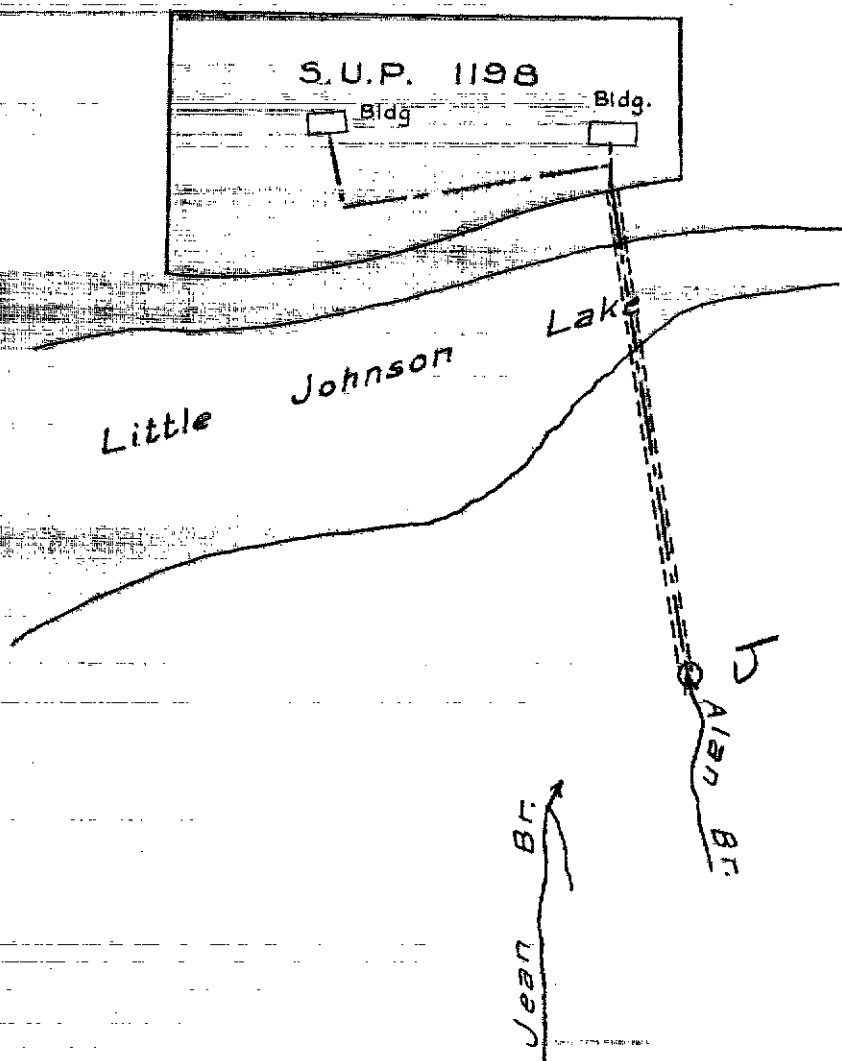

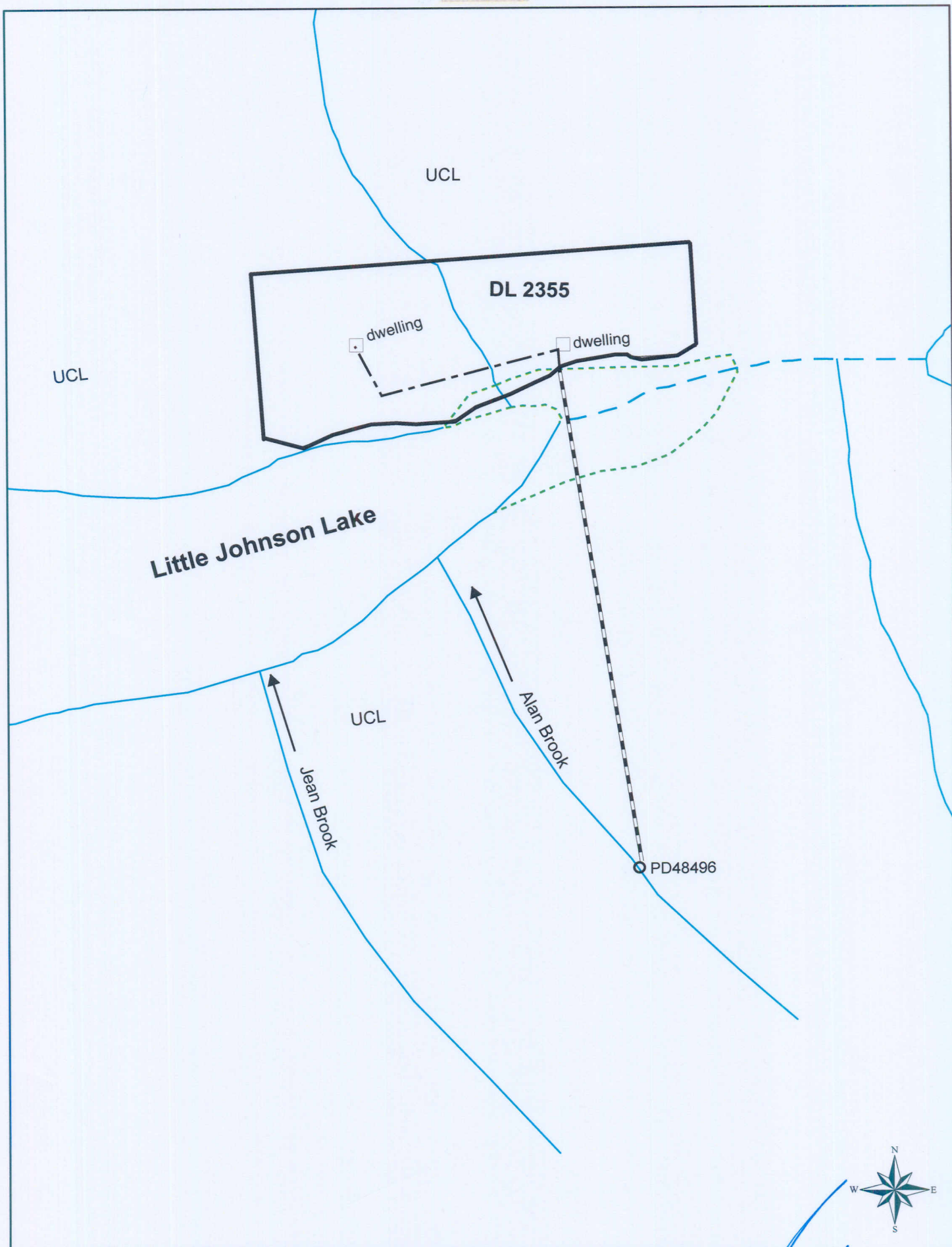
