
THE PROVINCE OF BRITISH COLUMBIA—WATER ACT

CONDITIONAL WATER LICENCE

Alan and Jean W. McGibbon of R.R.#1, Louis Creek, B.C.
is/are hereby authorized to divert and use water as follows:—
(a) The source(s) of the water-supply is/are Jean Brook.
(b) The point(s) of diversion is/are located as shown on the attached plan.
(c) The date from which this licence shall have precedence is 9th October, 1962.
(d) The purpose for which the water is to be used is power.
(e) The maximum quantity of water which may be diverted is 1 cubic foot per second
as the Engineer may from time to time determine should be allowed for losses.
(f) The period of the year during which the water may be used is the whole year.
(g) The land upon which the water is to be used and to which This licence is appurtenant is to a power house site on Special Timber Lease 13220P, Kamloops Division of Yale District, and the power generated may be transmitted and used on that part of Special Timber Lease 13220P, held under Special Use Permit 1198.
(h) The works authorized to be constructed are flume, intake box, penstock, power-house, pelton wheel, generator and transmission line.

(i) The construction of the said works has been completed and the water shall be beneficially used on or before the 31st day of December, 1966.






