### CONDITIONAL WATER LICENCE

- (a) The sources of the water-supply are Columbia River and its tributaries.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 16th March, 1972.
- (d) The purpose for which the water is to be used is power.
- (e) The maximum quantity of water which may be diverted is 65,000 cubic feet per second.
- (f) The period of the year during which the water may be used is the whole year.
- (g) This licence is appurtenant to the undertaking of the licensee.
- (h) The works authorized to be constructed are dam, power plant and auxiliary works which shall be located approximately as shown on the attached plan, and transmission lines and substations which shall be located on a route or routes selected by the licensee as required to convey electrical energy to points of use.
- (i) The construction of the said works shall be completed and the water beneficially used on or before the 31st day of December, 1987.
- (j) Construction of the works authorized under clause (h) hereof shall not be commenced until plans of same have been submitted to and have been approved in writing by the Comptroller of Water Rights.


IN THE MATTER of Conditional Water Licence 39431, which authorizes the diversion of water from the Columbia River for power purpose:
