


THE PROVINCE OF BRITISH COLUMBIA—WATER ACT
CONDITIONAL WATER LICENCE

Francis E. and Dorothy M. Walters of Box 745, Lillooet, B.C.

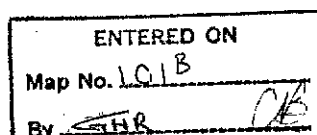
is/are hereby authorized to divert and use water as follows:—

- (a) The source(s) of the water-supply is/are Walters Spring.
- (b) The point(s) of diversion is/are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 15th August, 1972.
- (d) The purpose for which the water is to be used is domestic.
- (e) The maximum quantity of water which may be diverted is 1,000 gallons a day,
and such additional quantity
as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is
that part of Lot 1 of Lot 327, Lillooet District, Plan 17292,
lying east of road shown on said plan.
- (h) The works authorized to be constructed are diversion structure, pipe and trough,
which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be commenced on or before the 30th
day of September, 1973, and shall be completed and the water
beneficially used on or before the 31st day of December, 1976.

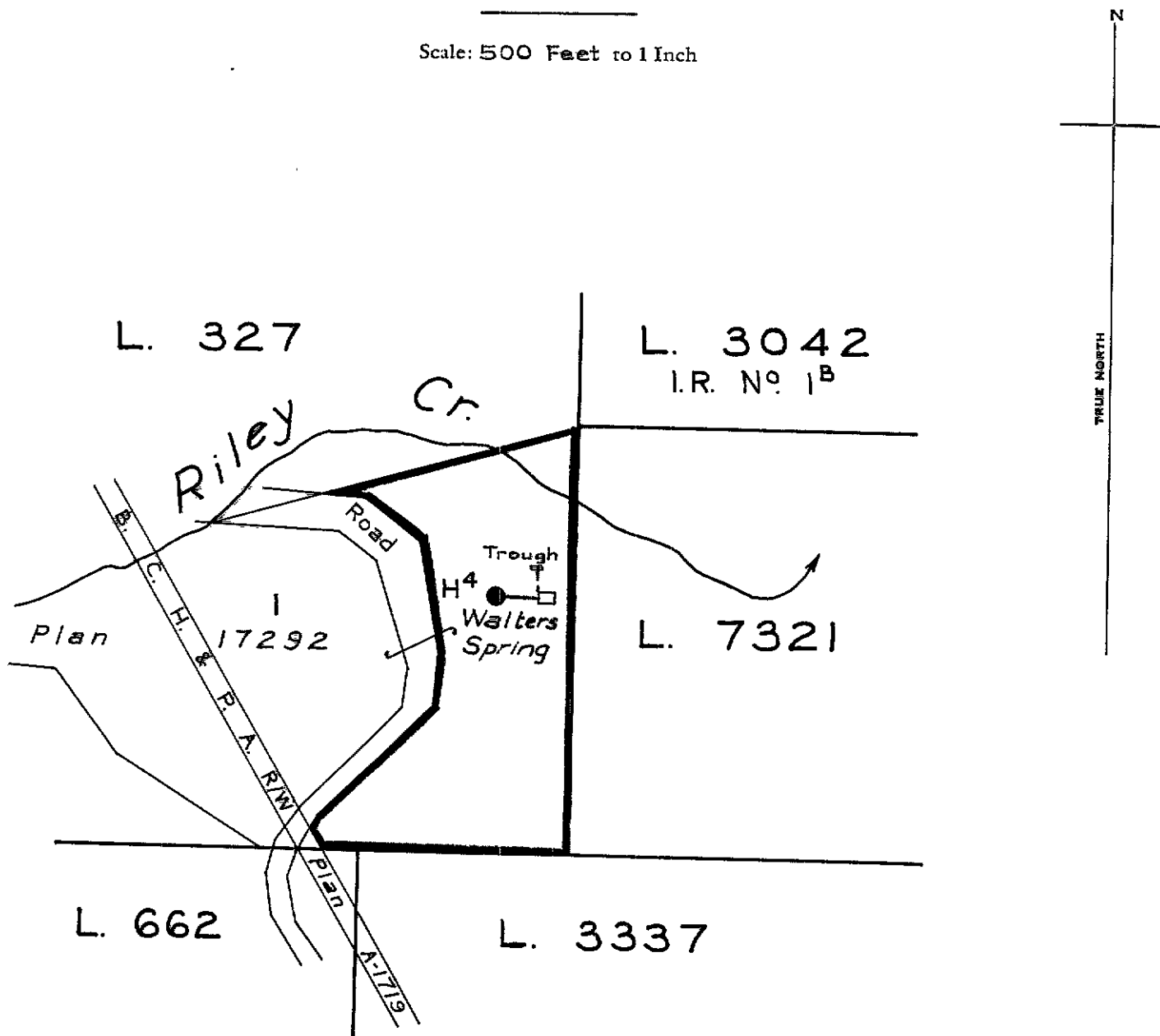

ORDER UNDER THE *WATER ACT*
SECTION 18

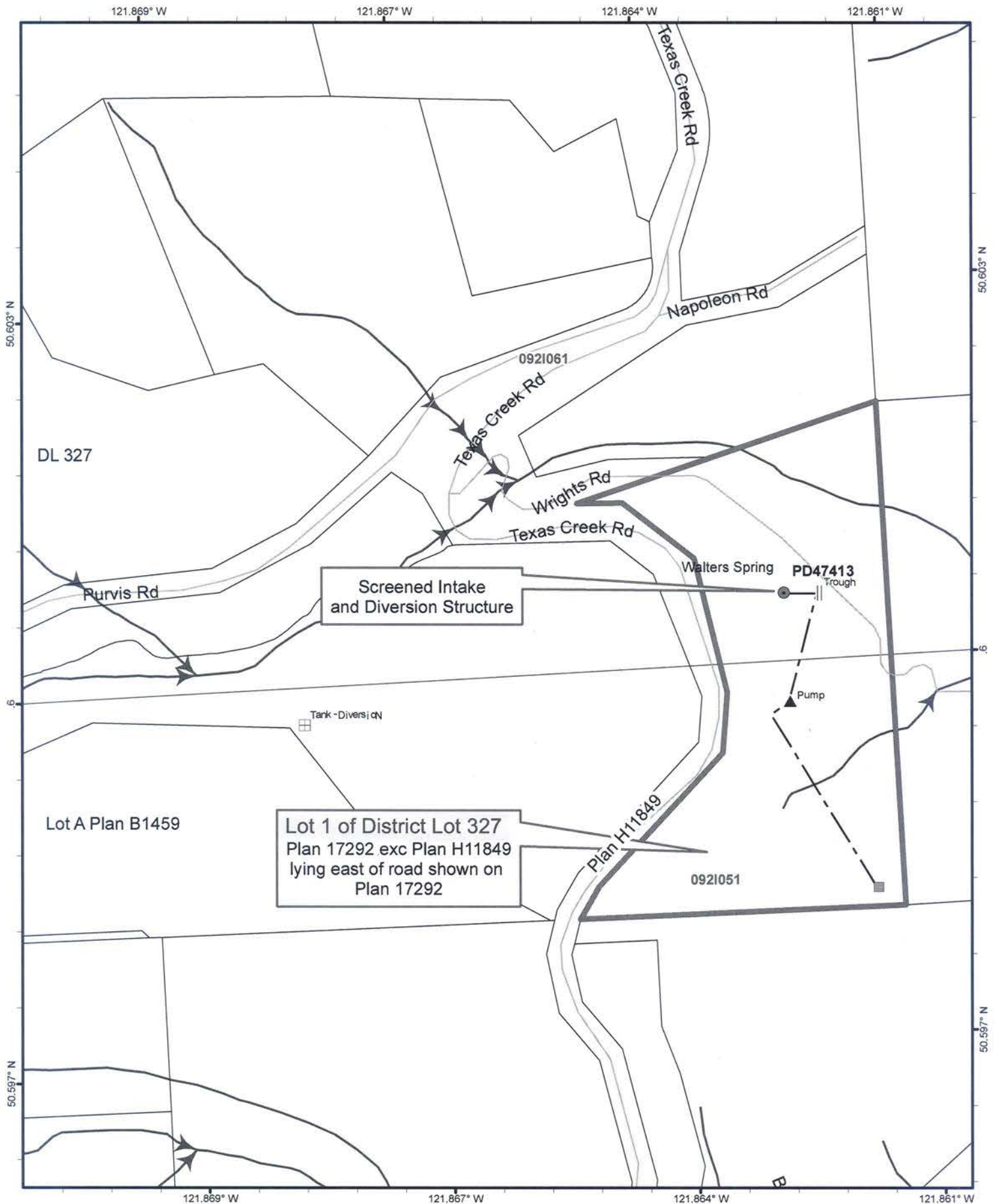
In the matter of Conditional Water Licence C040441, this authorizes the diversion of water from Walters Spring for domestic purposes within Lot 1 District Lot 327 Lillooet District, Plan 17292, lying east of the road shown on said plan.

Having determined that the land upon which the water is to be used and to which said licence is appurtenant has been re-described, and being satisfied that no person's rights will be injuriously affected I hereby amend clauses (b), (g) and (h) and add additional clauses (j) and (k) of the said licence, to read as follows:

- (b) The point of diversion is located as shown on the attached amended plan.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 District Lot 327 Lillooet District, Plan 17292 Except Plan H11849 lying east of the road shown on Plan 17292.
- (h) The works authorized to be constructed are diversion structure, screened intake, pipe, pump and trough which shall be located approximately as shown on the attached amended plan.
- (j) This licence is issued under the *Water Act* (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- (k) This licence authorizes the use of water for domestic purposes in one dwelling located approximately as shown on the attached amended plan.


