THE PROVINCE OF BRITISH COLUMBIA—WATER ACT  
CONDITIONAL WATER LICENCE

Herbert Lovgren of R.R. #1, Louis Creek, B. C. V0E 2E0

is/are hereby authorized to divert and use water as follows:—

- (a) The source(s) of the water-supply is/are Sinmax Creek.
- (b) The point(s) of diversion is/are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 24th January, 1974.
- (d) The purpose for which the water is to be used is irrigation.
- (e) The maximum quantity of water which may be diverted is 100 acre feet per annum,  
and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lots 1209, 831 and 1588, Kamloops Division of Yale District, of which 50 acres may be irrigated.
- (h) The works authorized to be constructed are diversion structures, portable pump, pipe and sprinkler system,  
which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works has been commenced and shall be completed and the water beneficially used on or before the 31st day of December, 1979.
- (j) The diversion of water authorized under this licence may be restricted or prohibited at any time by an order in writing of the Engineer for the Kamloops Water District in order to maintain a minimum flow in the stream for the preservation of fish life.

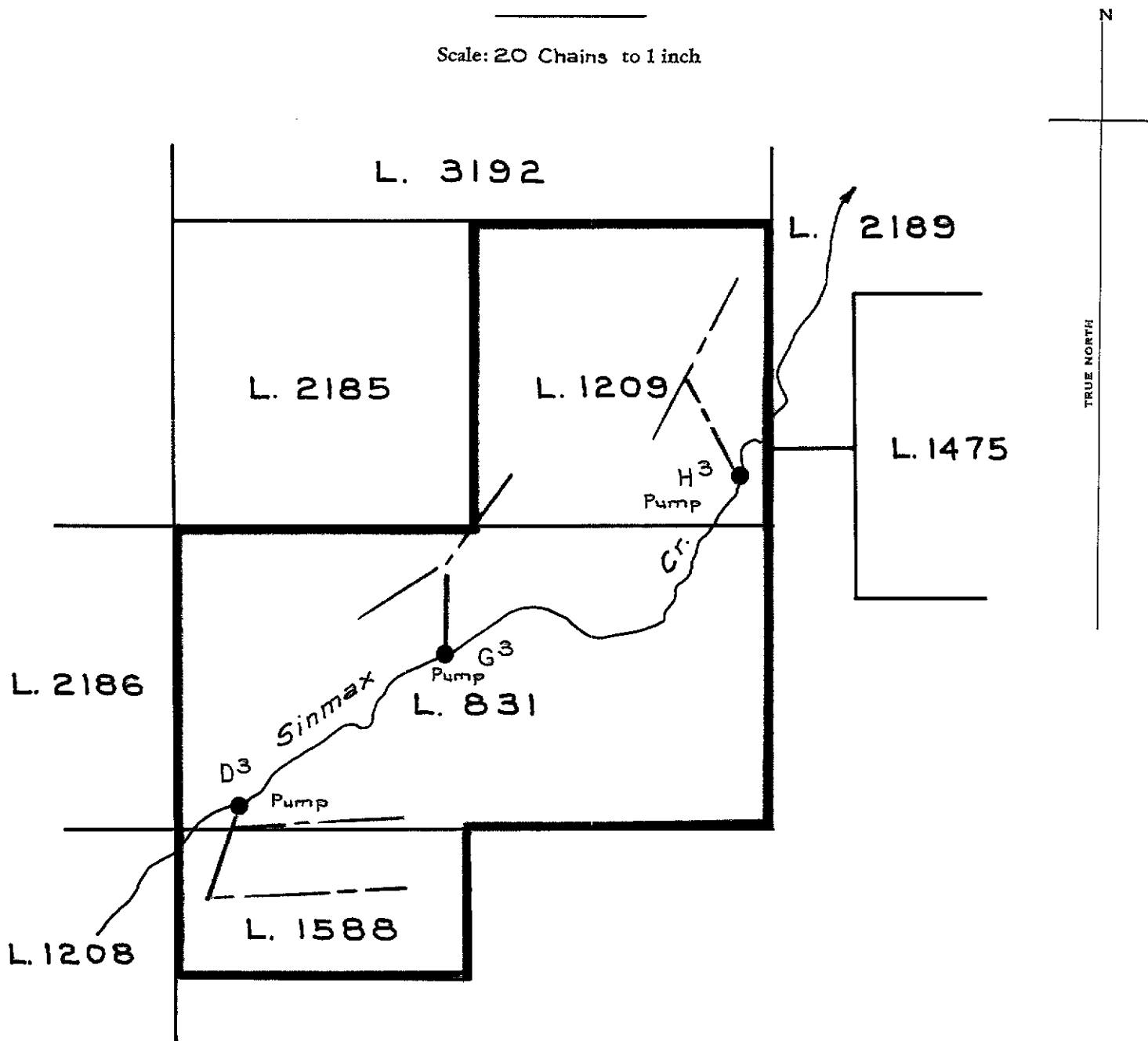
