CONDITIONAL WATER LICENCE

Sumas Clay Products, c/o Sumas Indian Band, 3087 Sumas Mountain Road, Kilgard, B.C.

is hereby authorized to divert and use water as follows:

- (a) The source of the water-supply is Bristo Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 5th February, 1940.
- (d) The purpose for which the water is to be used is industrial (manufacturing and sanitation).
- (e) The maximum quantity of water which may be diverted for industrial (manufacturing) purpose is 8,500 gallons a day and for industrial (sanitation) purpose is 1,500 gallons a day, and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is 1) the 6.19 acre parcel of Indian Reserve No. 6 (Upper Sumas) shown on Canada Lands Surveys Records Plan M2232; 2) Lot 46-1, Indian Reserve No. 6 (Upper Sumas), Canada Lands Surveys Records Plan 64772; and 3) all that part of Indian Reserve No. 6 (Upper Sumas) lying south of C.L.S.R. Plan 64772, north of C.L.S.R. Plan 66432, east of C.L.S.R. Plan M2232, and west of road right-of-way shown on C.L.S.R. Plan 52630, all within Group 2, New Westminster District.
- (h) The works authorized to be constructed are diversion structure and pipe, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works has been commenced and shall be completed and the water beneficially used on or before the 31st day of December, 1987.
- (j) This licence is issued in substitution of Final Water Licence 11027, in part, under Sections 16 and 17 of the Water Act.


