In the matter of Conditional Water Licence 60677, which authorizes storage of water from Baikie Creek in support of Conditional Water Licence 60676.

Having received a request to extend the period of time by which the works authorized by this licence shall be completed and being satisfied that no person's rights will be injuriously affected, I hereby amend Clause (i) of said licence to read as follows:

(i) The construction of the said works shall be commenced on or before the 30th day of November, 1984, and shall be completed and the water beneficially used on or before the 31st day of December, 1993.



- (a) The source of the water-supply is Baikie Creek and the reservoirs are Cedar Lake, Upper Cedar Lake and Camp Lake.
- (b) The points of storage are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 21st March, 1983.
- (d) The purpose for which the water is to be used is as set out in Conditional Water Licence 60676.
- (e) The maximum quantity of water which may be stored is a total of 740 acre feet per annum being divided as follows: 100 acre feet per annum in Cedar Lake, 340 acre feet per annum in Upper Cedar Lake and 300 acre feet per annum in Camp Lake, and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be stored is the whole year.
- (g) The land upon which the water is to be used and to which the licence is appurtenant is as set out in Conditional Water Licence 60676.
- (h) The works authorized to be constructed are dams, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be commenced on or before the 30th day of November, 1984, and shall be completed and the water beneficially used on or before the 31st day of December, 1987.
- (j) Construction of the dams authorized under clauses (h) hereof shall not begin until plans of same have been submitted to and approved by the Engineer for the Nanaimo Water District. Upon completion of construction two copies of final plans certified by the licensee's Engineer shall be filed with the Engineer for the Nanaimo Water District.


