
THE PROVINCE OF BRITISH COLUMBIA—WATER ACT

CONDITIONAL WATER LICENCE

Vernon Irrigation District of 2904 - 29th Avenue, Vernon, B. C. VIT 127

is hereby authorized to divert and use water as follows:

- (a) The source of the water-supply is Kalamalka Lake.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 21st August, 1893.
- (d) The purpose for which the water is to be used is waterworks.
- (e) The maximum quantity of water which may be diverted is 214,437,500 gallons a year, at a rate not exceeding 1,762,500 gallons a day, and such additional quantity as the Engineer may from time to time determine should be allowed for losses.
- (f) The period of the year during which the water may be used is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is all the lands within the boundaries of the Vernon Irrigation District.
- (h) The works authorized to be constructed are diversion structure, pump, pipe and distribution system, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be commenced on or before the 30th day of June, 1985, and shall be completed and the water beneficially used on or before the 31st day of December, 1999.
- (j) This licence is issued in substitution of Conditional Water Licence 17847, under Sections 15 and 20 of the Water Act.



ORDER UNDER THE WATER SUSTAINABILITY ACT SECTION 26

- h) The authorized works are screened intake, pipe and pump which shall be located approximately as shown on the attached amended plan.


