THE PROVINCE OF BRITISH COLUMBIA—WATER ACT

CONDITIONAL WATER LICENCE

Flora J. and Dale M. Hoban of R. R. #1, Sicamous, B. C. V0E 2B0

are hereby authorized to divert and use water as follows:

- (a) The source of the water supply is Sicamous Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 12th May, 1981.
- (d) The purposes for which this licence is issued are irrigation and domestic.
- (e) The maximum quantity of water which may be diverted for irrigation purpose is 4.0 acre feet per annum and for domestic purpose is 500 gallons a day.
- (f) The period of the year during which the water may be used for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Fractional Legal Subdivision 4 of Section 30, Township 21, Range 7, West of the 6th Meridian, Kamloops Division of Yale District, except Plans 11555, 24592, and Highway 97A (Plan H-741) of which 2 acres may be irrigated.
- (h) The works authorized to be constructed are diversion structure, pump, pipe and sprinkler system, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works has been completed and the water shall be beneficially used on or before the 31st of December, 1986.
- (j) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.

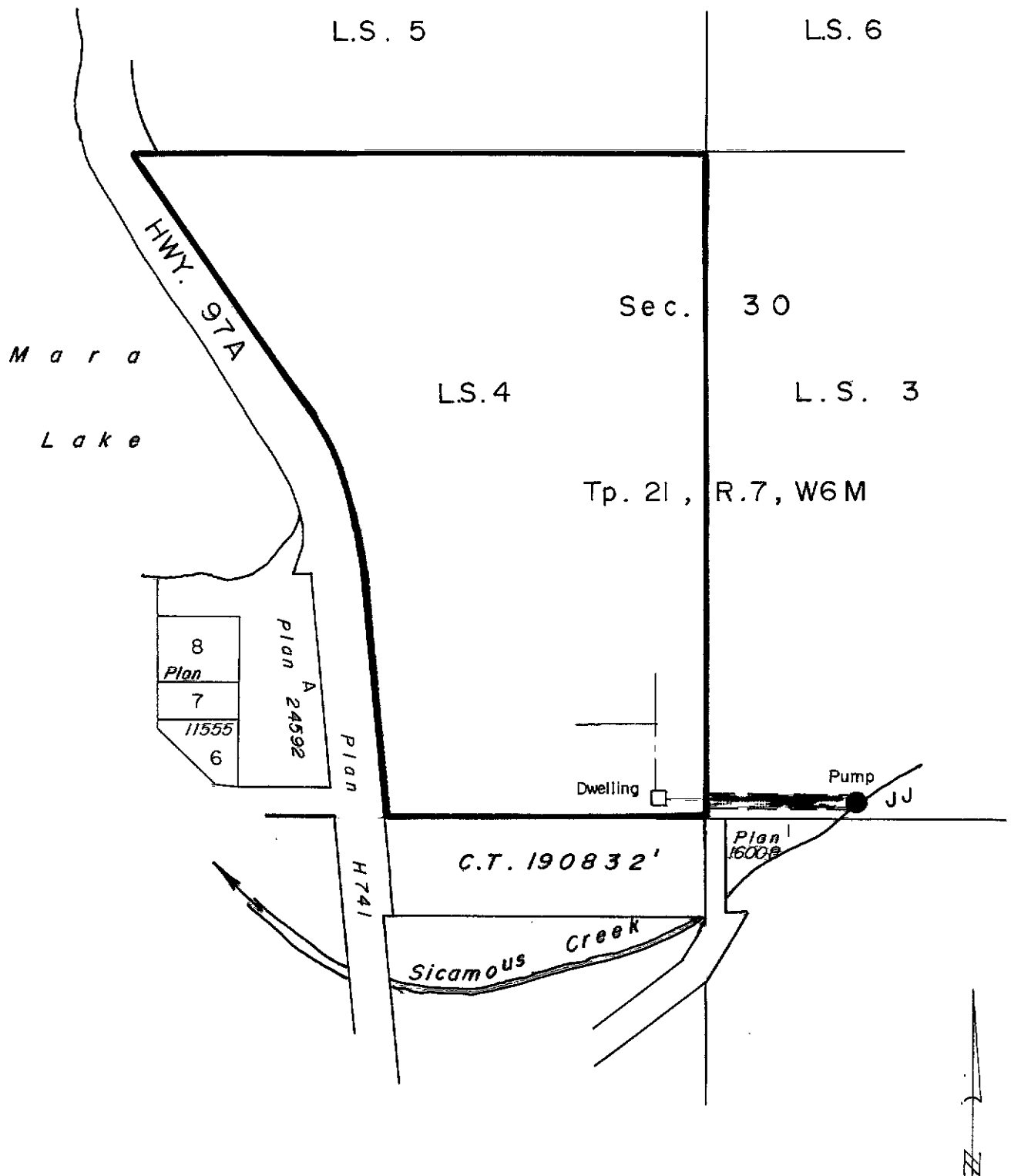
