- (h) The works authorized to be constructed are diversion structure, pipe and loading facilities, which shall be located approximately as shown on the attached plan. In addition, the licensee will be required to install a stream flow measuring station when and as ordered by the Comptroller of Water Rights.
- (i) The licensee shall not begin to construct the works until plans prepared by an engineer registered in British Columbia have been submitted to and leave to commence the construction is granted by the Comptroller of Water Rights.
- (j) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1989. Thereafter the licensee shall maintain the works to a standard set by the Comptroller of Water Rights and continue to make a regular beneficial use of the water in the manner authorized herein.
- (k) The licensee shall continuously monitor and provide stream flow records when as as ordered by the Comptroller of Water Rights.
- (1) The licensee shall annually provide the Comptroller of Water Rights with certified measurements of the volume of water used during the preceding calendar year.
- (m) This licence is issued for an inital term of fifteen (15) years. Upon application, the term of the licence may be extended by the Comptroller of Water Rights. Unless extended, this licence shall expire on the 17th day of July, 2001.


