



CONDITIONAL WATER LICENCE

Harper Ranch Ltd. of Box 59
Kamloops, British Columbia V2C 5K3

is hereby authorized to divert and use water as follows:

- (a) The stream on which the rights are granted is the South Thompson River.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 10th November, 1986.
- (d) The purpose for which this licence is issued is domestic.
- (e) The maximum quantity of water which may be diverted is 500 gallons a day.
- (f) The period of the year during which the water may be used is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot A of Lot 280, Kamloops Division Yale District, Plan 38710.
- (h) The authorized works are diversion structure, pump and pipe located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1990. Thereafter, the licensee shall continue to make beneficial use of the water in the manner authorized herein.
- (j) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.

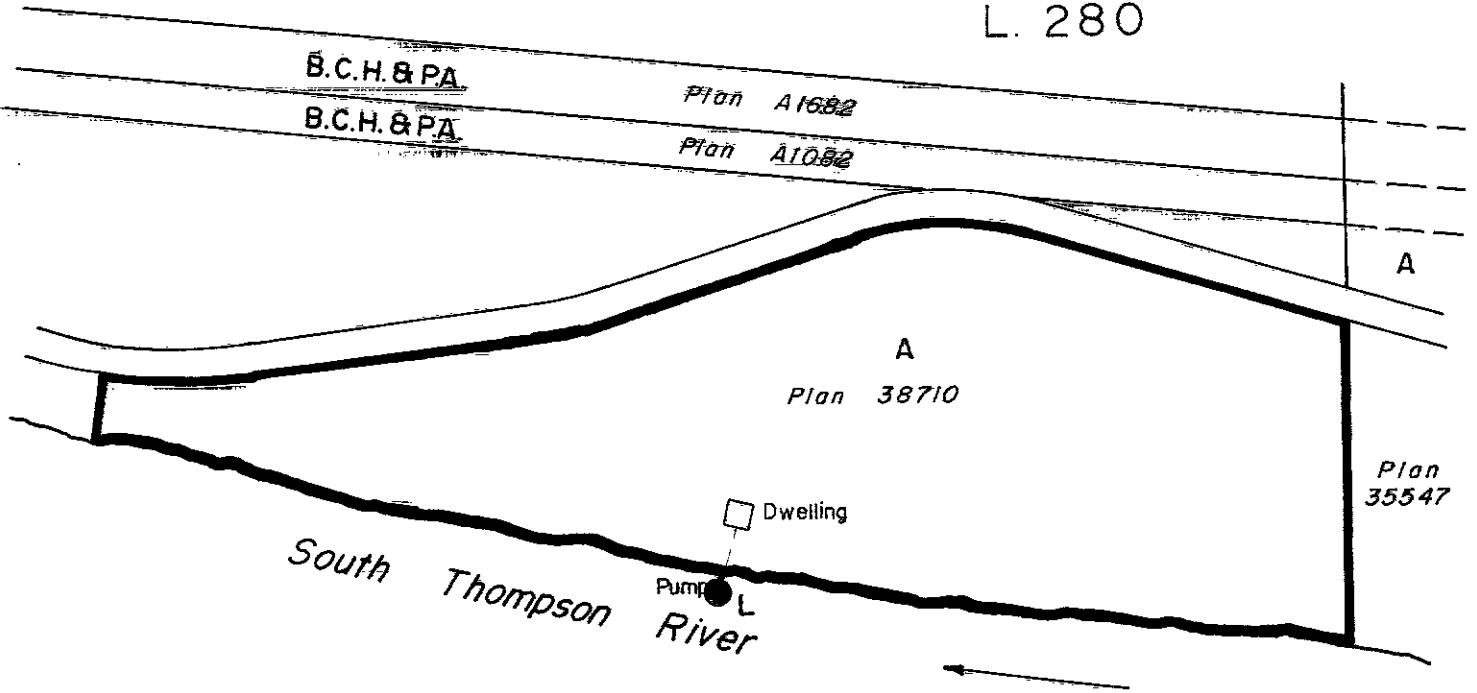



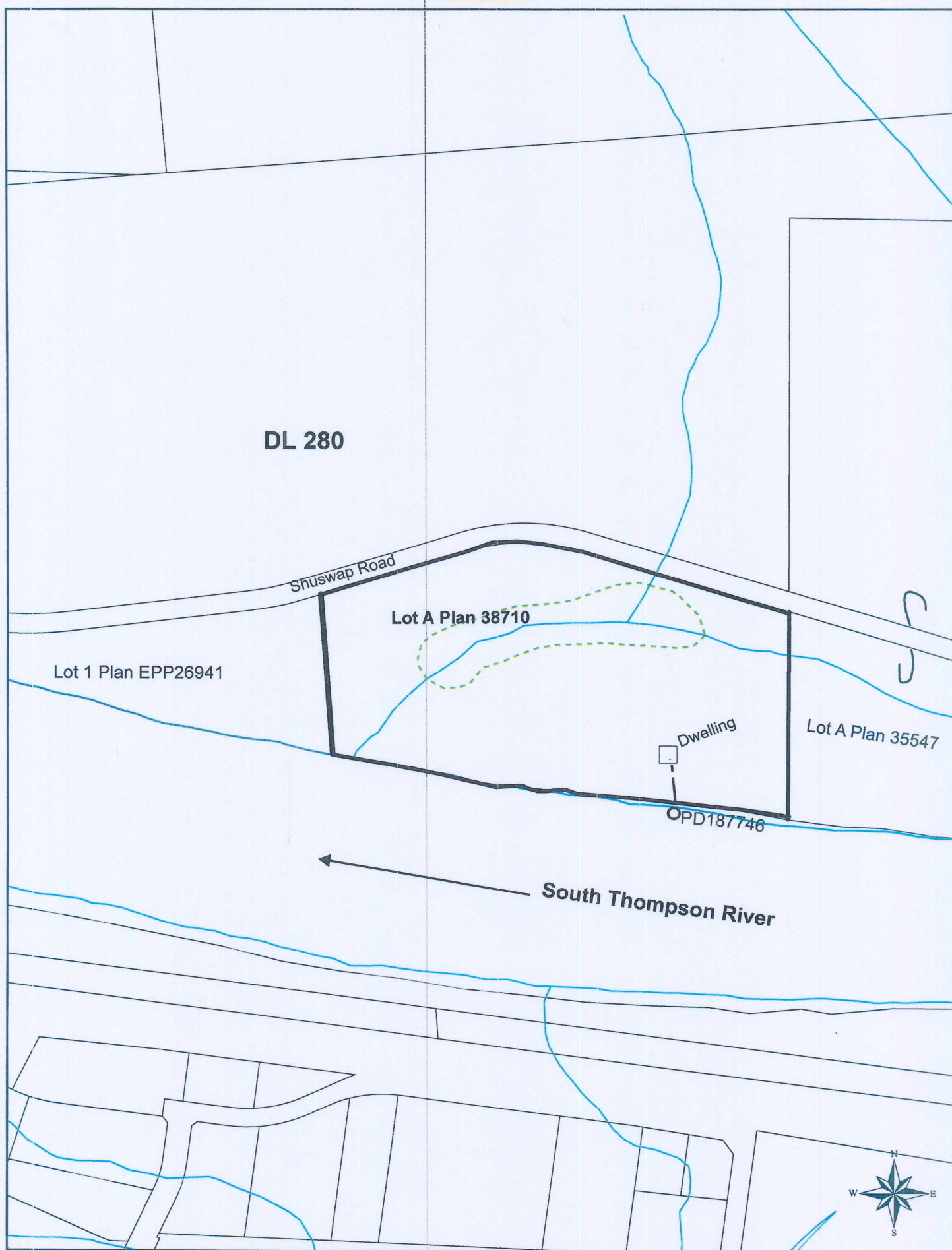
