

CONDITIONAL WATER LICENCE

Walter Enqvist, Helen Enqvist, Neil Enqvist and Sally Handley
of R.R. #1, Samuelson Road
Sicamous, British Columbia VOE 2V0

are hereby authorized to divert and use water as follows:

- (a) The stream on which the rights are granted is Bossley Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 25th August, 1986.
- (d) The purposes for which this licence is issued are irrigation and domestic.
- (e) The maximum quantity of water which may be diverted is 16 acre-feet per annum for irrigation purpose and 500 gallons a day for domestic purpose.
- (f) The period of the year during which the water may be used for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Block A of the Fractional Northwest 1/4 of Section 8, Township 22, Range 7, West of the 6th Meridian, Kamloops Division Yale District of which 8 acres may be irrigated.
- (h) The authorized works are diversion structure, pipe and sprinkler system located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1991. Thereafter, the licensee shall continue to make beneficial use of the water in the manner authorized herein.
- (j) The domestic purpose authorized by this licence is for use in one dwelling located approximately as shown on the attached plan.

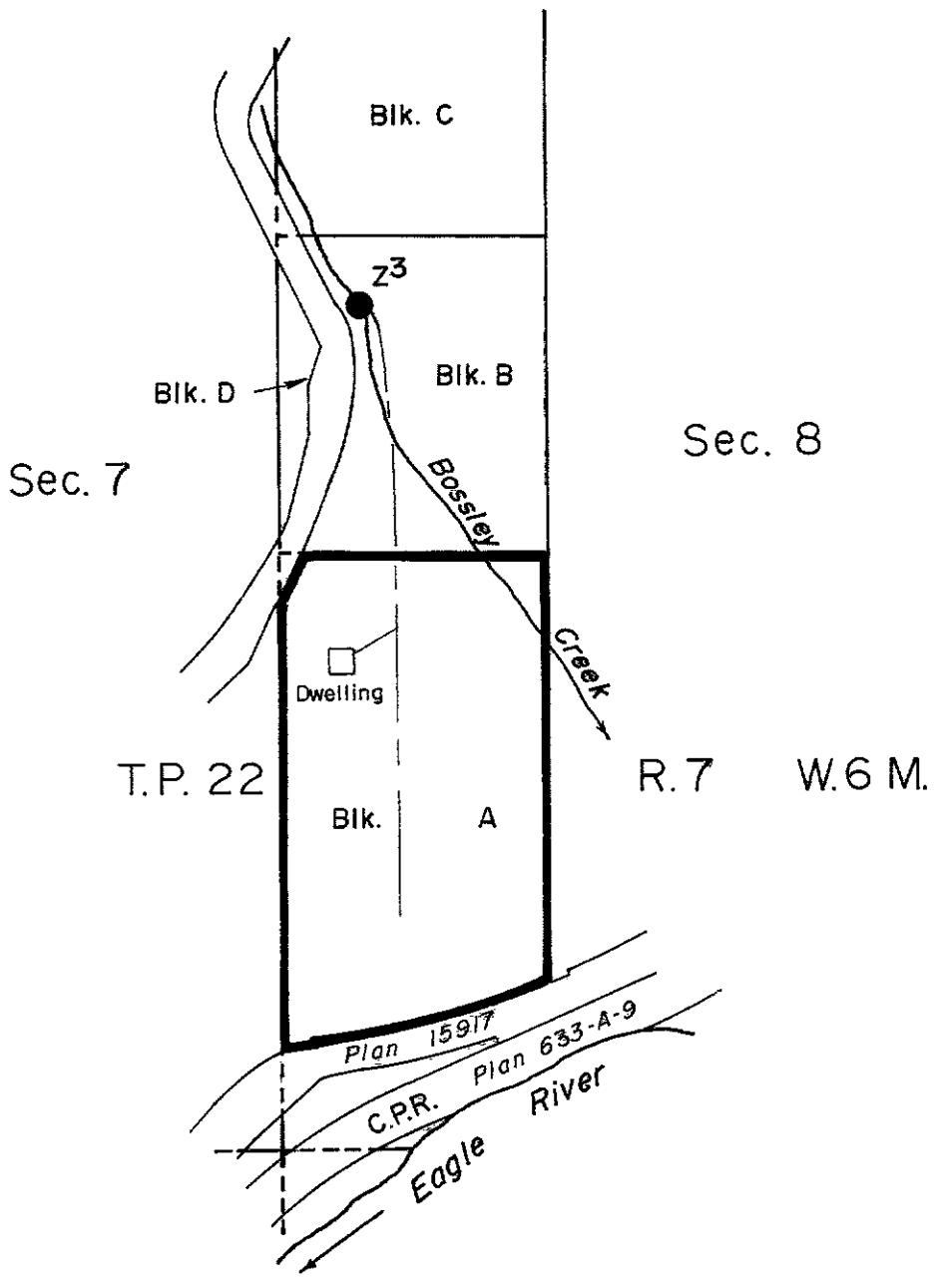
