

THE PROVINCE OF BRITISH COLUMBIA—WATER ACT
CONDITIONAL WATER LICENCE

GERARD GUICHON RANCH LIMITED of Quilchena, B.C. VOE 2R0

is hereby authorized to divert, store and use water as follows:

- (a) The stream on which the rights are granted is Mildred Creek and the reservoir is Critter Lake.
- (b) The storage site and points of diversion and rediversion are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 25th September, 1979.
- (d) The purposes for which this licence is issued are storage and irrigation.
- (e) The maximum quantity of water which may be stored and diverted is 80.0 acre-feet per annum.
- (f) The period of the year during which the water may be stored is 1st October to 30th June and used for irrigation is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lots 100, 103 and 104 and the Northeast 1/4 of Section 7, all of Township 99, Kamloops Division Yale District of which 40 acres may be irrigated.
- (h) The authorized works are dam, diversion structures, ditches and flumes located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1993. Thereafter, the licensee shall continue to make beneficial use of the water in the manner authorized herein.
- (j) Construction or reconstruction of the dam shall not be commenced until plans have been submitted to and written leave to commence construction granted by an engineer under the Water Act.

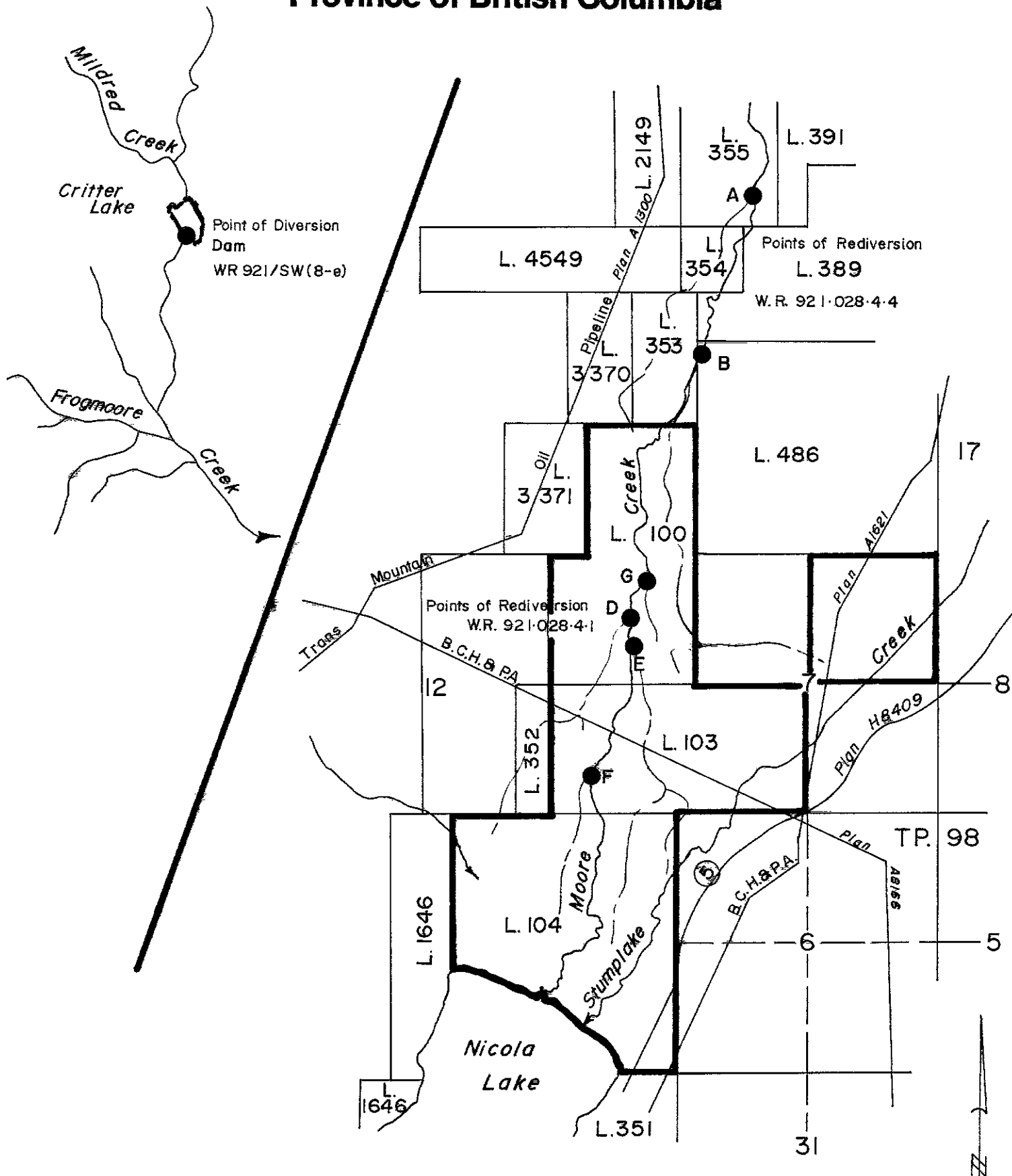

Section 18 *Water Act* (Ch. 486, R.S.B.C. 1996)

IN THE MATTER OF Conditional Water Licence 67057 authorizing the irrigation and storage of 80 acre feet per annum for irrigation and storage purposes for use on Lots 100, 103 and 104 and the Northeast ¼ Section 7 all of Township 99 Kamloops Division Yale District.

HAVING DETERMINED THAT the works associated with this licence have not been built and being satisfied that no person's rights will be injuriously affected, I hereby amend clause (i) of said licence to read as follows:

- (i) The plans for construction of the dam shall be submitted and accepted by the Dam Safety Officer by the January 31st, 2013. The construction of the dam shall be completed and the water beneficially used by January 31st, 2015. Thereafter, the licensee shall continue to make regular beneficial use of water in the manner authorized herein.
