THE PROVINCE OF BRITISH COLUMBIA—WATER ACT  
CONDITIONAL WATER LICENCE

Charles R. Burton of Site 38, Box 2, RR #2, Creston, B.C. VOB 1G0  
is hereby authorized to divert and use water as follows:

- (a) The stream on which the rights are granted is Joseph Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 15th August, 1968.
- (d) The purposes for which this licence is issued are irrigation and domestic.
- (e) The maximum quantity of water which may be diverted for irrigation purpose is 2.75 acre feet per annum and for domestic purpose is 500 gallons a day.
- (f) The period of the year during which the water may be used for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot B of District Lot 8977, Kootenay District, Plan 16707, of which 2.20 acres may be irrigated.
- (h) The works authorized to be constructed are diversion structure, pipe and sprinkler system, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make a regular beneficial use of the water in the manner authorized herein.
- (j) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- (k) This licence is issued in substitution of Final Water Licence 42570, in part.



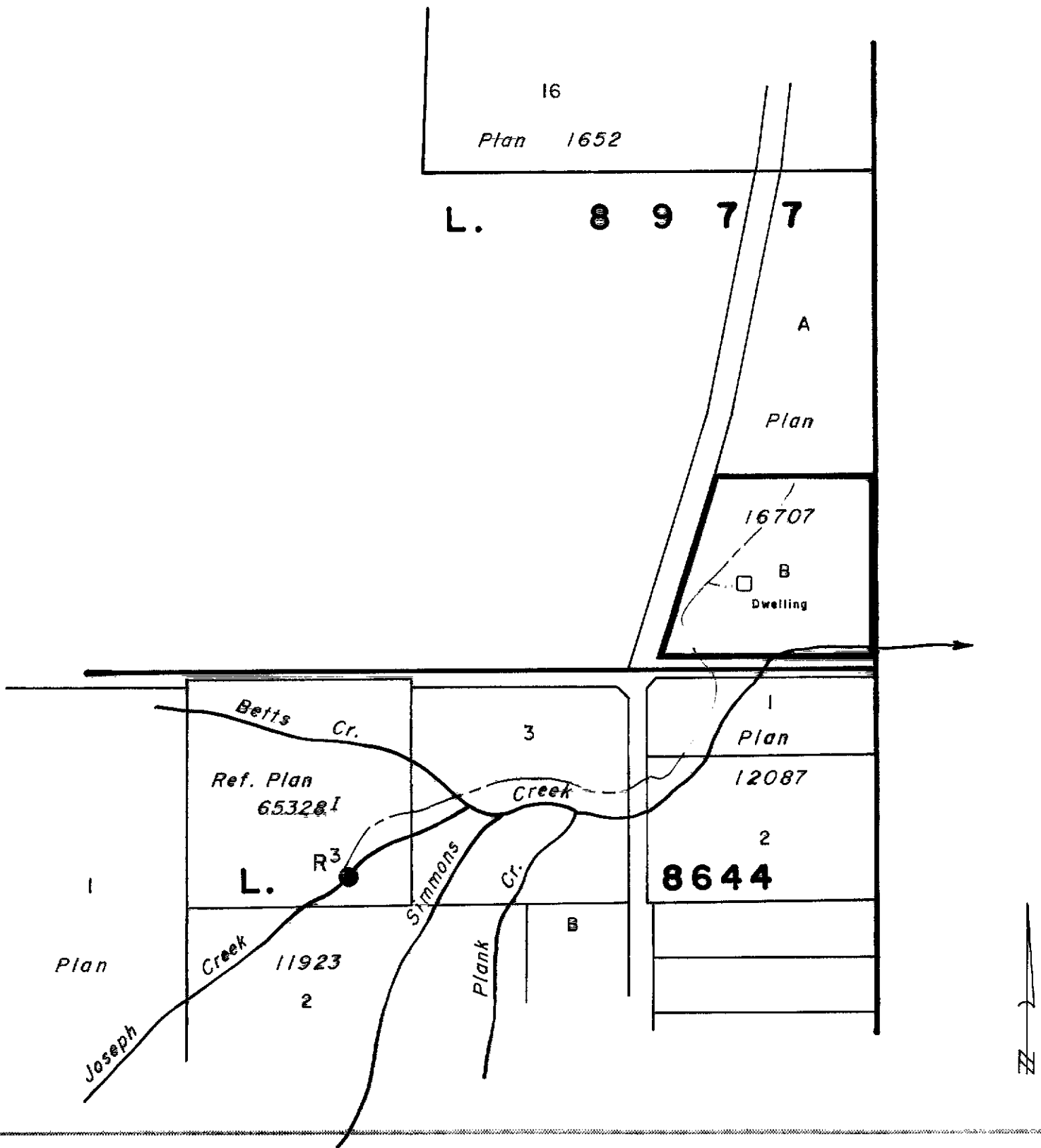
