

THE PROVINCE OF BRITISH COLUMBIA—WATER ACT

CONDITIONAL WATER LICENCE

Ivan and Louise Clifton of RR #1, Keremeos, B.C. VOX 1N0

are hereby authorized to divert and use water as follows:

- (a) The stream on which the rights are granted is Bullock Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 11th July, 1907.
- (d) The purposes for which this licence is issued are irrigation and domestic.
- (e) The maximum quantity of water which may be diverted for irrigation purpose is 19.53 acre feet per annum and for domestic purpose is 350 gallons a day.
- (f) The period of the year during which the water may be used for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 2467, Similkameen Division of Yale District, of which 6.51 acres may be irrigated.
- (h) The works authorized to be constructed are diversion structure, pipe and sprinkler system, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1993. Thereafter, the licensee shall continue to make a regular beneficial use of water in the manner authorized herein.
- (j) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- (k) This licence is issued in substitution of Final Water Licence 5275 #2 in part, in accordance with the February 16, 1990 decision of the Environmental Appeal Board.



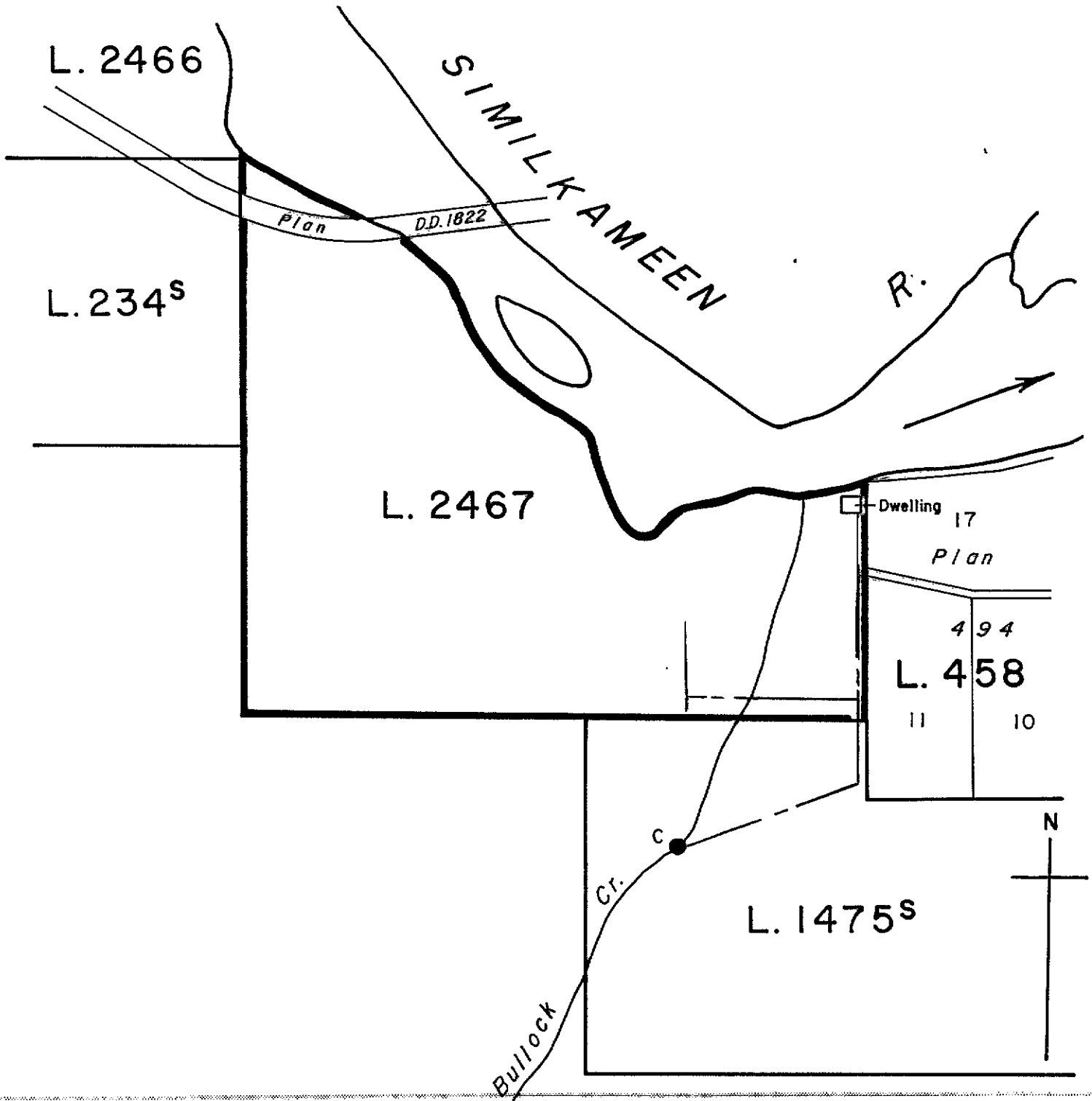

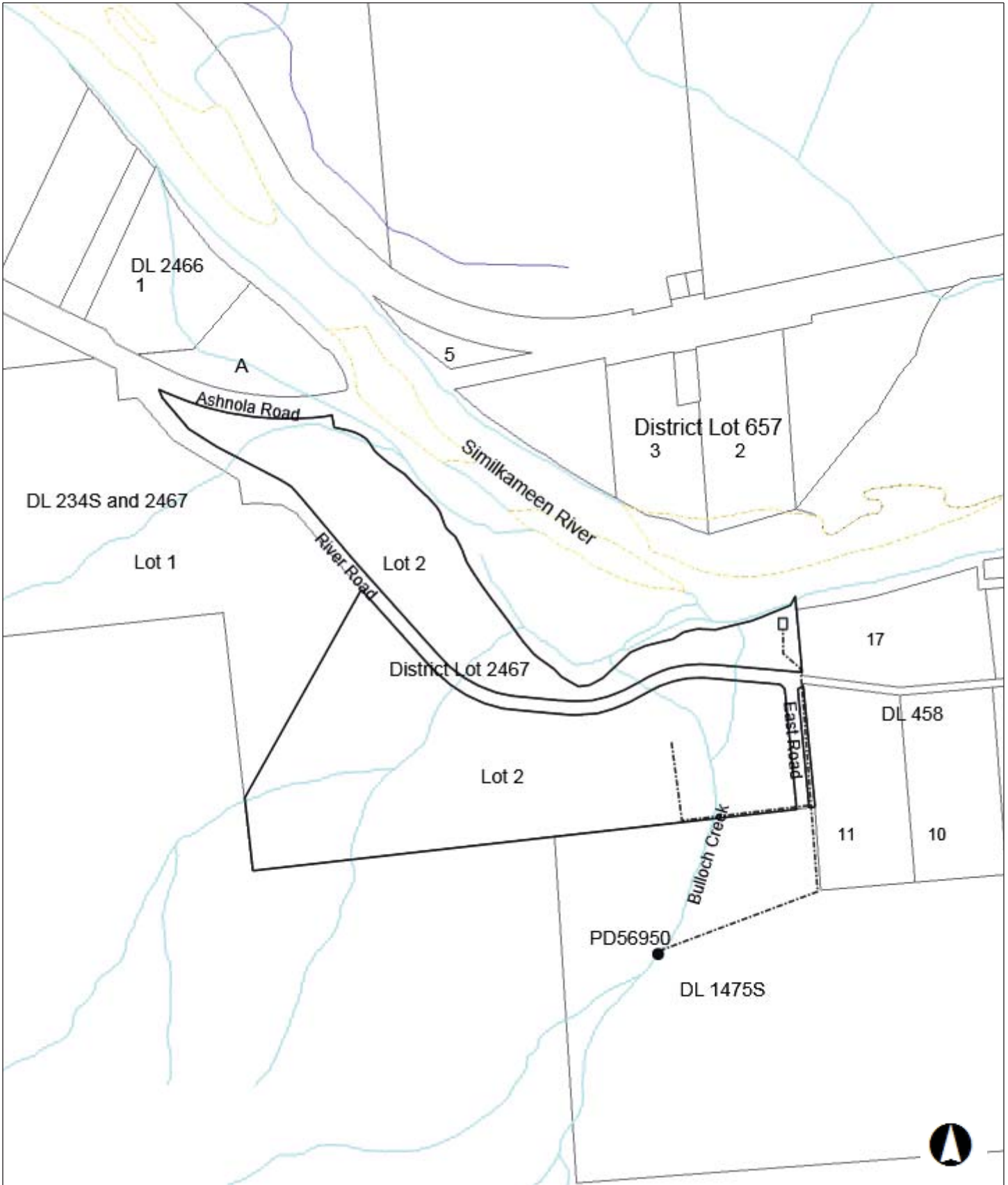
Having determined that the land upon which the water is to be used and to which said licence is appurtenant has been re-described, and being satisfied that no person's rights will be injuriously affected I hereby amend clause (g) of the said licence to read as follows:

(g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 2 District Lot 2467 Similkameen Division Yale District Plan KAP50817, of which 2.635 hectares (6.51 acres) may be irrigated.
