CONDITIONAL WATER LICENCE

The owner of the land to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- (a) The stream on which the rights are granted is Ahbau Creek and the reservoir is an offstream reservoir.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 9th February, 1989.
- (d) The purposes for which this licence is issued are storage and irrigation.
- (e) The maximum quantity of water which may be diverted for irrigation purposes is 310 acre feet of which 100 acre feet may be held in storage.
- (f) The period of the year during which water may be diverted to fill the reservoir is the 1st of March to 15th of July, the stored water may be used for irrigation purpose from 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 3306, 7598, 7599, and 12814 all of Cariboo District, of which 310 acres may be irrigated.
- (h) The works authorized to be constructed are screened intake, reservoir, pump, pipe and sprinkler system, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to the 31st day of December, 1997. Thereafter, the licensee shall continue to make regular beneficial use of water in the manner authorized herein.
- (j) The reservoir authorized under clause (h) hereof shall not be constructed until the plans have been submitted to and written leave to commence granted by an Engineer under the Water Act.
- (k) This licence will expire on the same date as Crown Lease #701604 which expires on August 4th, 1996. Upon application, this licence may be extended for additional terms for diversion of specified quantities of water by the Regional Water Manager or the Comptroller of Water Rights.


