CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source of the water-supply is Trinity Creek.
- (b) The point of diversion is located as shown on the attached _____ plan.
- (c) The date from which this licence shall have precedence is February 8, 1972. _____
- (d) The purpose for which this licence is issued is irrigation.
- (e) The maximum quantity of water which may be diverted is 75 _____ acre feet per annum.
- (f) The period of the year during which the water may be used is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 2739, Osoyoos Division Yale District, except Plan 30604, of which 50 acres may be _____irrigated.
- (h) The works authorized to be constructed are diversion structure, pump, pipe and irrigation system, located approximately as shown on the attached plan.

(i) The construction of the said works shall be completed and the water shall be beneficially used on or before the 31st day of December 1998. Thereafter, the licensee shall continue to make regular beneficial use of water in the manner authorized herein.

(j) This licence is issued in substitution of Conditional Water Licence 41914, in part.


