
CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is Dynamite Lake.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 21st February, 1997.
- (d) The purpose for which this licence is issued is irrigation.
- (e) The maximum quantity of water which may be diverted is 50 acre feet per annum.
- (f) The period of the year during which the water may be used is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is East 1/2 of District Lot 4094, Lillooet District, of which 25 acres may be irrigated.
- (h) The authorized works are diversion structure, pump, pipe and sprinkler system which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December 2005. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.

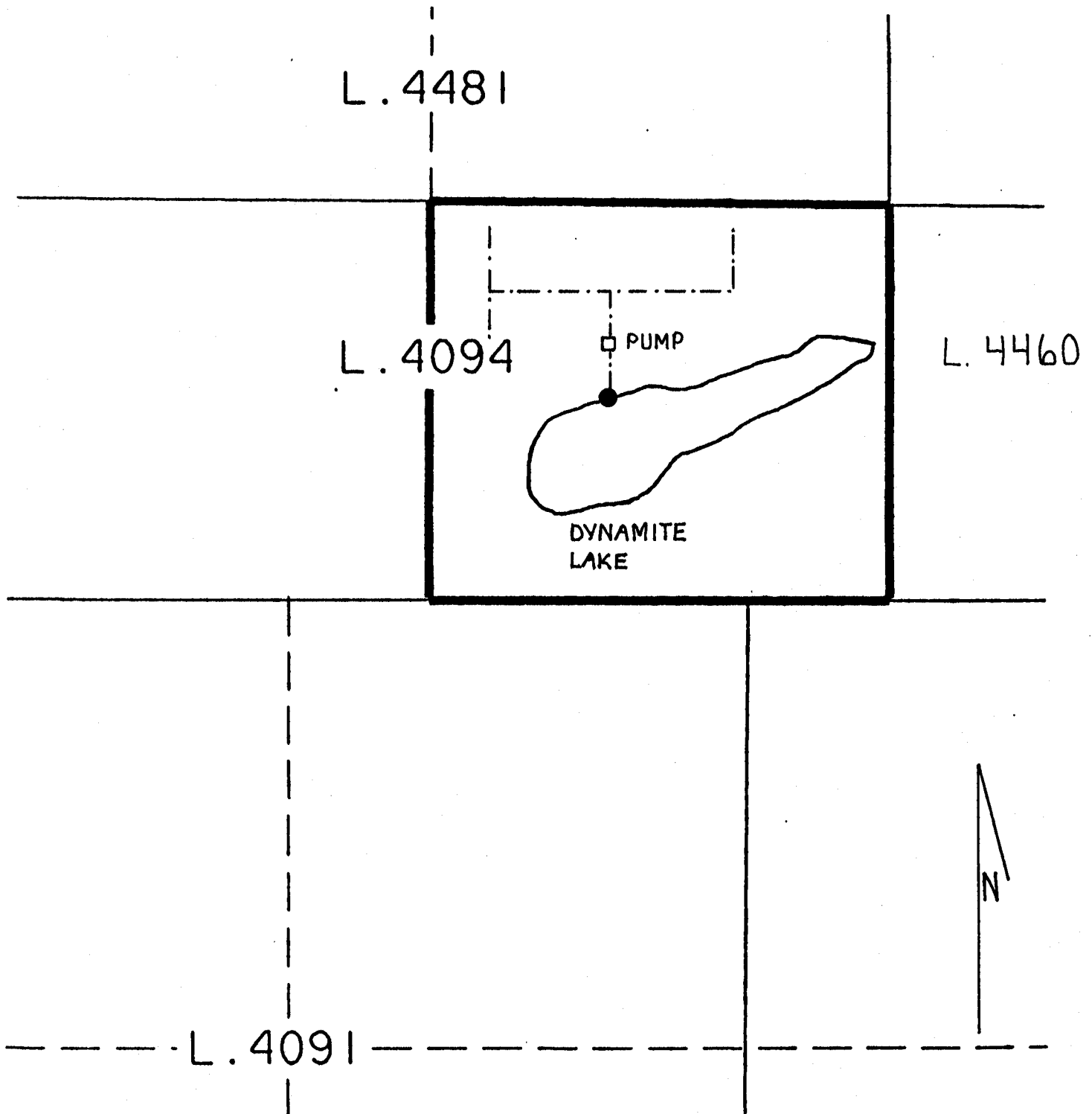

Section 26 *Water Sustainability Act* (Bill 18-2014)

IN THE MATTER OF Conditional Water Licence 112085 authorizing the diversion and use of 50 acre feet per annum for irrigation purpose for use within the east 1/2 of District Lot 4094, Lillooet District.

HAVING DETERMINED THAT the legal description of the land of which the water is to be used and to which this licence is appurtenant has changed, and being satisfied that no person's rights will be injuriously affected, I hereby amend clause g of said licence to read as follows:

Clause g: The land upon which the water is to be used and to which this licence is appurtenant is the east portion of Lot A, District Lot 4094, Lillooet District, Plan KAP82787, formerly described as the east ½ of District Lot 4094, Lillooet District, of which 25 acres may be irrigated.
