THE PROVINCE OF BRITISH COLUMBIA—WATER ACT  
CONDITIONAL WATER LICENCE

The holder of a lease held under BCAL file No. 2403170 covering the land to which this licence is appurtenant is hereby authorized to divert, store and use water as follows:

- (a) The stream on which the rights are granted is **Sandhill Creek**.
- (b) The point of diversion and storage site are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is **19<sup>th</sup> September, 1997**.
- (d) The purposes for which this licence is issued are **power (commercial) and storage**.
- (e) The maximum quantity of water which may be diverted for **power (commercial) purpose is 0.71 cubic feet per second and for storage purpose is 9.0 acre feet per annum**.
- (f) Water may be used throughout **the whole year**.
- (g) The land upon which the water is to be used is **part of District Lot 1743, Range 1, Coast District**, on which a powerhouse is situated, and the land to which the licence is appurtenant is **unsurveyed foreshore or land covered by water being part of the bed of Phillips Arm, Range 1, Coast District, held under Licence of Occupation on File No. 2403170**.
- (h) The works authorized to be constructed are **diversion structure, dam, pond, pipe, powerhouse and transmission line** which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used prior to **31st December, 2003**. Thereafter, the licensee shall continue to make a regular beneficial use of water in the manner authorized herein.
- (j) The power generated may be supplied to a **Salmon Farm** located approximately as shown on the attached plan.
- (k) The diversion of water authorized under this licence may be restricted or prohibited at any time by an order in writing of an engineer under the Water Act in order to maintain a minimum flow in the stream for the preservation of fish life.

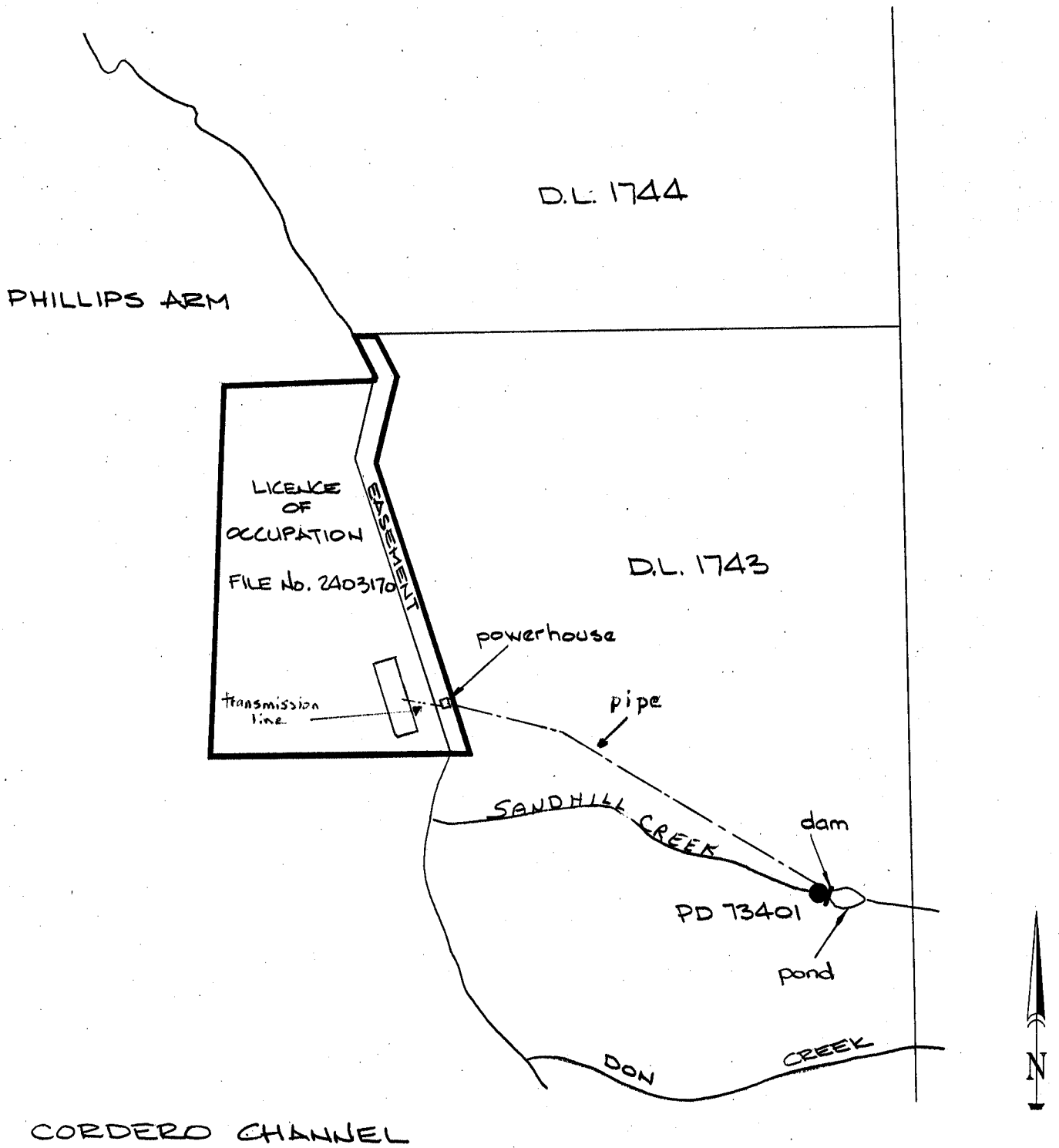
