



ORDER UNDER THE WATER ACT
SECTION 18

In the matter of Conditional Water Licence 114892 which authorizes the diversion of water from Joseph Spring for domestic purpose on the Legal Subdivision 8 of Section 5, Township 23, Range 9, West of the 6th Meridian, Kamloops Division Yale District, except Plans H14991, B7426, KAP47383 and KAP64756.

Having determined that the land upon which the water is to be used and to which said licence is appurtenant has been re-described, and being satisfied that no person's rights will be injuriously affected I hereby amend clause (g) of the said licence to read as follows:

(g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 Section 5 Township 23 Range 9 West of the Sixth Meridian Kamloops Division Yale District Plan KAP79834.

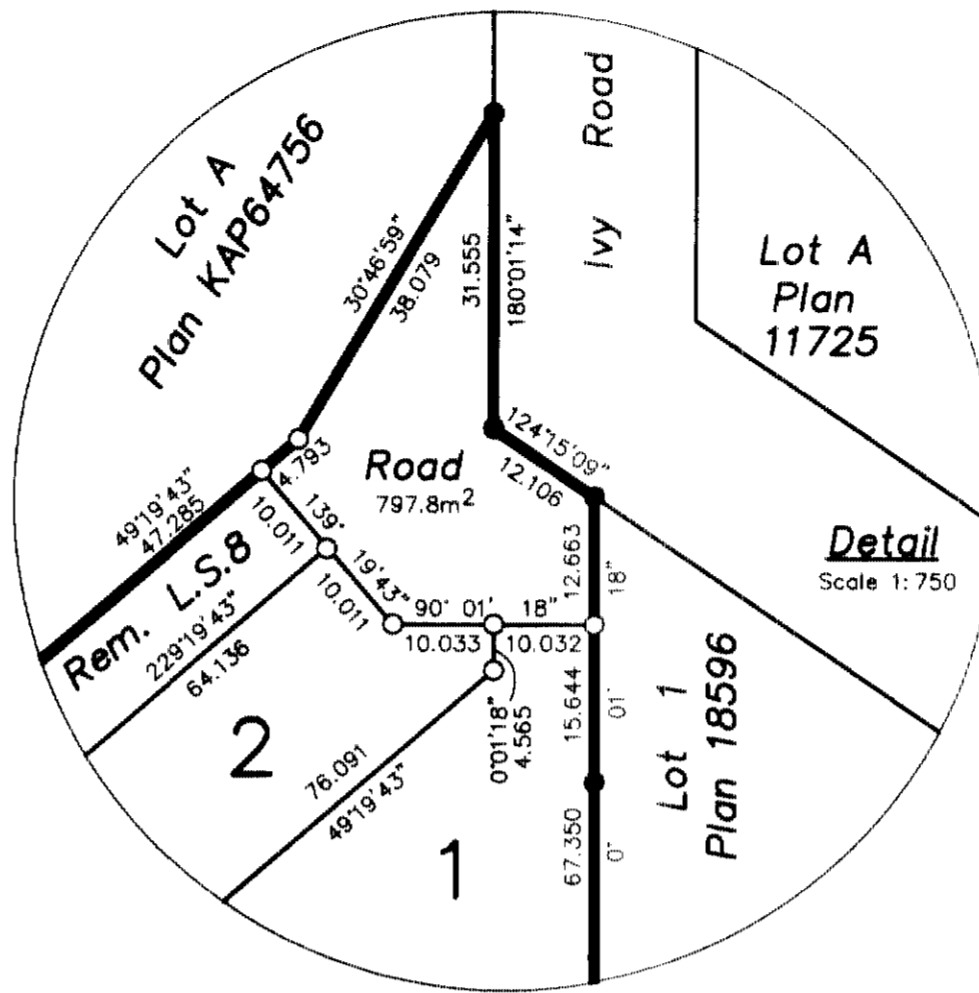
