Re: Final Water Licence 120651 – Bull River and the Reservoir is Bull River Headpond

Enclosed please find a copy of an Order amending clause (h) of Final Water Licence 120651 which authorizes the storage of water from Bull River and the reservoir is Bull River Headpond. The stored water supports the power purpose at the Aberfeldie Generating Station as set out in Final Water Licence 120650.

It has come to my attention that the reservoir was not included in the authorized works when Final Water Licence 120651 was issued. The enclosed amendment Order has been issued to correct this matter.

A right of appeal from my decision lies to the Environmental Appeal Board. Notice of any appeal must (1) be in writing, (2) include grounds for the appeal, (3) be directed by registered mail to the Chair, Environmental Appeal Board, P.O.Box 9425 Stn. Prov. Govt. V8W 9V1, or personally delivered to the office of the Board at 4th Floor, 747 Fort Street in Victoria, B.C. V8W 3E9 (4) be delivered within 30 days of receiving this letter, and be accompanied by a fee of \$25, payable to the Minister of Finance. WATER ACT

ORDER

Water Act Section 18

WHEREAS Final Water Licence No. 120651 authorizes the storage of water from Bull River and the reservoir is Bull River Headpond.

WHEREAS clause (h) of Final Water Licence 120651 states:

- (h) *The works authorized are Aberfeldie dam with outlets and overflow spillway which are located as shown on the attached plan.*

WHEREAS the reservoir known locally as Bull River Headpond is shown on the plan attached to Final Water Licence 120651, the reservoir however was omitted from the works described in clause (h) of the licence.

WHEREAS I am satisfied that no person's rights will be injuriously affected.

I HEREBY AMEND CLAUSE (h) OF FINAL WATER LICENCE 120651 AS FOLLOWS:

- (h) *The works authorized are Aberfeldie dam with outlets, spillway, and reservoir which are located as shown on the attached plan.*
