CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is McKinnon Creek.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 17th August, 1927.
- (d) The purposes for which this licence is issued are domestic and irrigation.
- (e) The maximum quantity of water which may be diverted for domestic purpose is 500 gallons per day and the maximum quantity of water which may be diverted for irrigation purpose is 3.66 acre feet per annum.
- (f) The period of the year during which the water may be used is the whole year for domestic and 1st April to 30th September for irrigation.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is that part of Lot E, District Lot 12474, Kootenay District, Plan NEP22505, lying east of Avis Road, of which 2.9 acres may be irrigated.
- (h) The authorized works are diversion structure and pipe which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works has been completed and, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- (j) The diversion of water authorized under this license may be restricted or prohibited at any time by an order in writing of an engineer under the *Water Act* in order to maintain a minimum flow in the river for the preservation of aquatic life.
- (k) When required to do so by an Engineer under the *Water Act*, the licensee shall install works to meter and record the rate of flow and quantity of water diverted under this licence. Flow meter records shall be retained by the licensee and be available upon request for inspection by the Engineer.
- (I) This licence is issued pursuant to the provisions of the *Water Act* to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.
- (m) The domestic purpose authorized by this licence is for use in one dwelling located approximately as shown on the attached plan.

(n) This licence is issued in substitution of Final Water Licence 008802, in part.




