CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is Sierra Spring.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 5th October, 2004.
- (d) The purposes for which this licence is issued are storage, irrigation and domestic.
- (e) The maximum quantity of water which may be diverted for storage purpose is 5 acre feet per annum, for irrigation purpose is 5 acre feet per annum and for domestic purpose is 1500 gallons per day.
- (f) The period of the year during which the water may be used for storage purpose is 1st October to 30th April, for irrigation purpose is 1st April to 30th September and for domestic purpose is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Section 19, Township 24, Osoyoos Division Yale District, except Plans 475, 31650, 42893, KAP46332, KAP46387, KAP47043, KAP53815, KAP57295 and KAP68087; and the West ½, Section 20, Township 24, Osoyoos Division Yale District, except Plans 42893 and KAP57295, of which 5 acres may be irrigated.
- (h) The authorized works are diversion structure, pond, pump, pipe and irrigation system which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December 2007. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- (j) This licence is issued pursuant to the provisions of the Water Act to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.
- (k) Any water diverted and used under this licence for irrigation purpose during the period 1st April to 30th September, must be taken from storage provided in the pond authorized herein.
- (I) The domestic purpose authorized by this licence is for use in one dwelling.


