## *Water Sustainability Act*

### CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Peavine Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is 23rd April, 1869.
- d) The purpose[s] for which this licence is issued are domestic and irrigation.
- e) The maximum quantity of water which may be diverted for domestic is 1.137 cubic metres per day and the maximum quantity which may be used for irrigation is 7400 cubic metres per annum.
- f) The period of the year during which the water may be used for domestic is the whole year and for irrigation is April 1 to September 30.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 District Lots 777 and 778, Lillooet District Plan KAP74958 except Plan KAP91796 of which 0.81 hectares may be irrigated.
- h) The authorized works are a diversion structure, pipe and sprinklers which shall be located approximately as shown on the attached plan. The irrigation works shall be restricted in flow to 1.7 liters per second, and shall have a gauging weir and volumetric flow meter installed prior to any re-diversions off of the mainline, all to the satisfaction of the "Engineer" (note that "Engineer" within this paragraph refers to the Engineer under the Water Sustainability Act (Bill 18-2014))
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to May 4, 2019. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Sustainability Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on

the stream or on an aquifer. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

- k) This licence authorizes the use of water for domestic purpose in (1) one dwelling located approximately as shown on the attached plan.
- l) The licensee shall submit to the Comptroller of Water Rights, Water Manager, or an Engineer a Beneficial Use Declaration and a drawing prepared to the water licence application drawing standards showing the point of diversion, area of beneficial use, all associated works, and the legal boundaries of the appurtenant land, on or before the 4th day of May 2019.
- m) The licensee shall install a flow measuring device to the satisfaction of an Engineer under the Water Sustainability Act.
- n) This Licence is issued in substitution of Conditional Water Licence 122225, in part.
