

CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is Trott Gulch.
- (b) The point of diversion is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 19th December, 2005.
- (d) The purpose for which this licence is issued is domestic & industrial (stock watering).
- (e) The maximum quantity of water which may be diverted is 500 gallons per day for domestic purpose & 500 gallons per day for industrial (stock watering) purpose.
- (f) The period of the year during which the water may be used is the whole year.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is District Lot 2186, Kamloops Division Yale District.
- (h) The authorized works are a diversion structure, pipe and trough which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December 2009. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- (j) This licence is issued pursuant to the provisions of the Water Act to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.
- (k) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- (l) The industrial (stock watering) purpose authorized by this licence is for use outside the wetted perimeter of the source in a trough located approximately as shown on the attached plan.
- (m) The rights granted under this licence are subject to a water reserve established by Order in Council 1511 dated November 12, 1919.
- (n) This licence is issued in substitution of Final Water Licence 13298, in part.

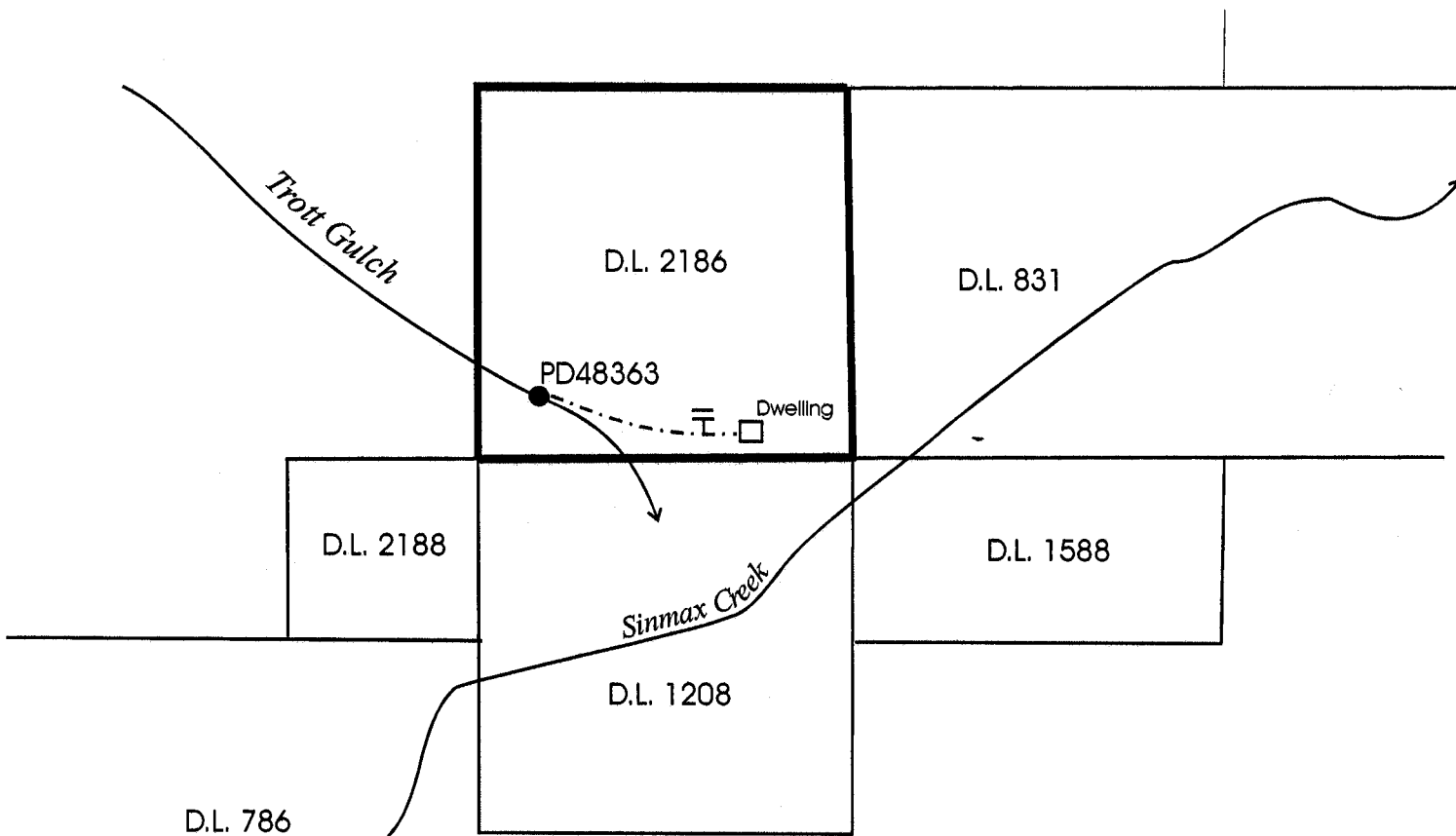
