CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- (a) The source on which the rights are granted is Hutchison Lake and the reservoir is Hutchison Lake.
- (b) The storage site and points of diversion are located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is September 21, 1979.
- (d) The purposes for which this licence is issued are irrigation and storage.
- (e) The maximum quantity of water which may be diverted is 20 acre feet per annum for irrigation purpose, subject to the water being available from storage, and 20 acre feet per annum for storage.
- (f) The period of the year during which the water may be used to fill the reservoir is October 1st to June 15th and the stored water may be used during the period from April 1st to September 30th.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 1 District Lot 3863 Lillooet District Plan KAP58622 of which 10 acres may be irrigated.
- (h) The authorized works are a dam, intake, pump, pipe and irrigation system which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December 2011. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- (j) This licence is issued pursuant to the provisions of the *Water Act* to ensure compliance with that statute, which makes it an offence to divert or use water from a stream in British Columbia without proper authorization. It is the responsibility of the licensee to ensure that all activities conducted under this authorization are carried out with regard to the rights of third parties, and comply with other applicable legislation that may be in force.
- (k) This licence is issued in substitution of Conditional Water Licence 68652, in part.

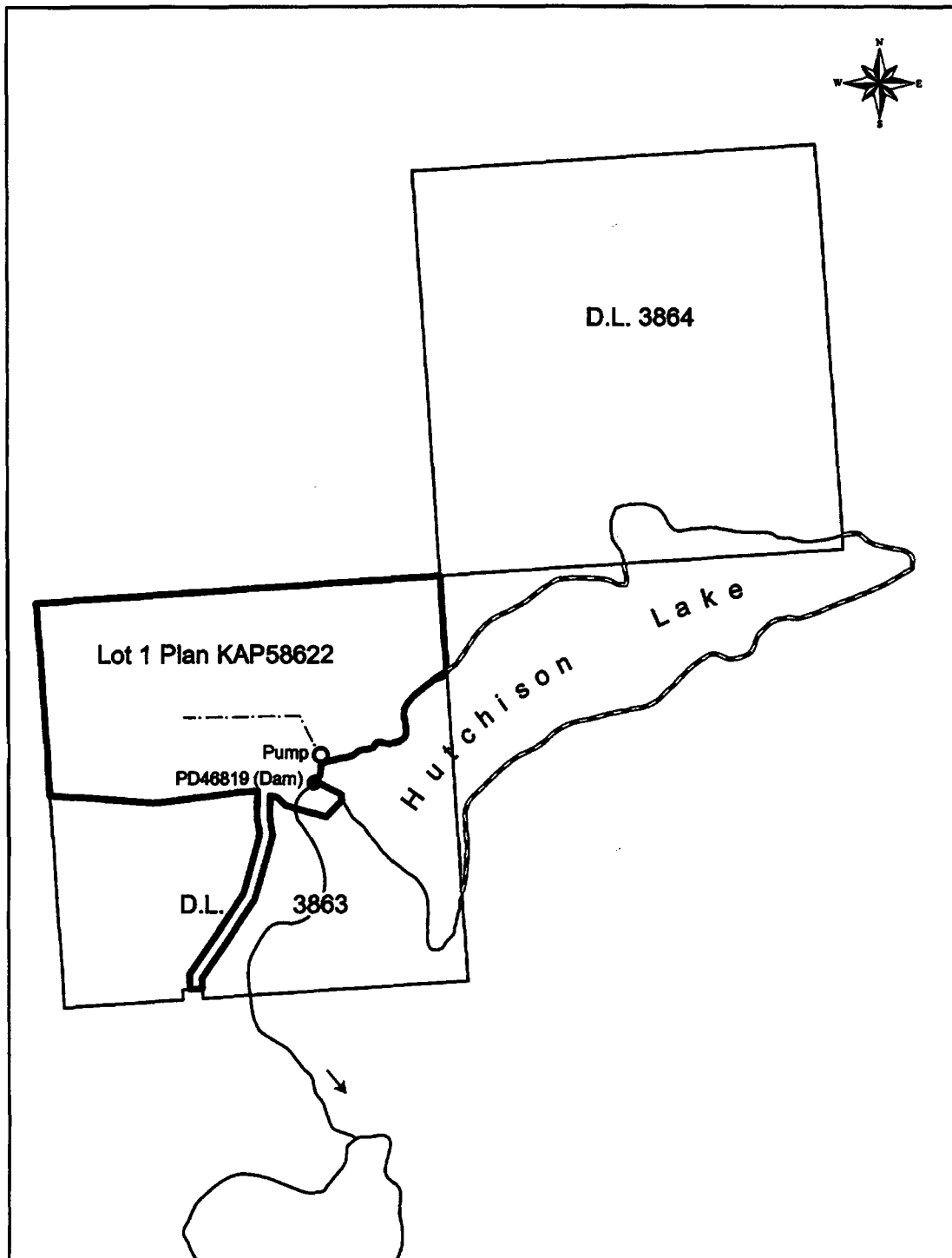
