

### Province of British Columbia Water Act

#### FINAL WATER LICENCE

British Columbia Hydro and Power Authority is hereby authorized to store water as follows:

- a) The stream on which the rights are granted is Bridge River, and the reservoir is Carpenter Lake Reservoir.
- b) The site of the dam which creates Carpenter Lake Reservoir is PD 47063 located as shown on the attached plan.
- c) The date from which this licence shall have precedence is December 26, 1912.
- d) The purpose for which this licence is issued is storage. Storage purpose supports the power purpose at Bridge River BR1 and BR2, and Seton generating stations under Final Water Licences F126080, F126250, F126282, F126286, F126287 and F126288.
- e) Conditions for the storage of water in Carpenter Lake Reservoir are as follows:
  - i) The water may be stored in the reservoir between elevations of 606.55 metres, the minimum operating level, and 651.08 metres, the full supply level, measured at the dam using Geodetic Survey of Canada (GSC) datum.
  - ii) The volume of water authorized to be stored between the minimum operating level and full supply level under this licence and Final Water Licence F126280 is estimated to be 1012.49 million cubic metres. Of this total, 20.0 million cubic metres is authorized under this licence.
  - iii) Surcharging the reservoir above the full supply level, drafting the reservoir to the full supply level and drafting the reservoir below the minimum operating level shall be done in accordance with the Operation, Maintenance and Surveillance Manual.
- f) The water may be collected into storage, held in storage, and used throughout the whole year.
- g) This licence is appurtenant to the undertaking as set out in Final Water Licences F126080, F126250, F126282, F126286, F126287 and F126288.
- h) The authorized works are a dam, spillway and low level outlet at PD 47063 and Carpenter Lake Reservoir located as shown on the attached plan, and ancillary works associated with the operation of the dam.




