British Columbia Hydro and Power Authority is hereby authorized to store water as follows:

- a) The stream on which the rights are granted is Seton River, and the reservoir is Seton Lake Reservoir.
- b) The site of the dam which creates Seton Lake Reservoir is PD 47373 located as shown on the attached plan.
- c) The date from which this licence shall have precedence is April 27, 1953.
- d) The purpose for which this licence is issued is storage. Storage purpose supports the power purpose at Seton River generating station under Final Water Licence F126282.
- e) Conditions for the storage of water in Seton Lake Reservoir are as follows:
 - i) The water may be stored in the reservoir between elevations of 235.76 metres, the minimum operating level, and 236.36 metres, the full supply level, measured at Bridge River generating station BR1 using Geodetic Survey of Canada (GSC) datum.
 - ii) The volume of water authorized to be stored between the minimum operating level and full supply level under this licence is estimated to be 14.80 million cubic metres.
 - iii) Surcharging the reservoir above the full supply level, drafting the reservoir to the full supply level and drafting the reservoir below the minimum operating level shall be done in accordance with the Operation, Maintenance and Surveillance Manual.
- f) The water may be collected into storage, held in storage, and used throughout the whole year.
- g) This licence is appurtenant to the undertaking as set out in Final Water Licence F126282.
- h) The authorized works are a dam, spillway, radial gate, low level outlet and siphons at PD 47373 and Seton Lake Reservoir, located as shown on the attached plan, and ancillary works associated with the operation of the dam.
- i) The levels of Seton Lake Reservoir shall not exceed such elevation as may be set from time to time by the Comptroller of Water Rights.




