CONDITIONAL WATER LICENCE

The holder of the leases to which this licence is appurtenant is hereby authorized to divert and use as follows:

- a) The source on which the rights are granted is Williston Lake Reservoir.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is October 26, 2010.
- d) The purpose for which this licence is issued is industrial (oilfield injection).
- e) The maximum quantity of water which may be diverted for industrial purpose (oilfield injection) is 10,000 cubic meters per day to a maximum of 3,650,000 cubic meters per year.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Oil & Gas activities within that parcel or tract of unsurveyed Crown land held under the Petroleum and Natural Gas Lease system, No. 15492, 3030, 61360, 61341, 57404, 62489, 62543, 62664, 62667, 63397, 63392, 63455, and 63563; as well as land tenure licences 57483, 60073, 60075, 60076, 61383, 61384, 61690, 62180, 63367, 63269, and 63570; Peace River District.
- h) The authorized works are screened intake, pump, and pipe which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2014. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) The licensee shall install a flow measuring device to the satisfaction of the Regional Water Manager or an Engineer under the Water Act and shall retain flow meter records for inspection upon request by an Engineer under the Water Act.

- k) This licensee shall keep records on actual water use; this information shall be submitted by June 1st of each year as an annual report to the Regional Water Manager.

- l) This licence will remain in good standing as long as the agreement between the British Columbia Hydro and Power Authority and Talisman Energy Inc. as holder of the appurtenant leases and licences is active and in good standing.

- m) This licence terminates on December 31, 2031. Prior to the termination date, the licensee may apply to the Comptroller of Water Rights or the Regional Water Manager in accordance with the provisions of the Water Act to amend this licence to extend its term.

WATER ACT SECTIONS 22 and 85(2)

WHEREAS, Progress Energy Canada Ltd. is the holder of Conditional Water Licence C126568;

WHEREAS, Conditional Water Licence C126568 contains condition “k” stating “*This licensee shall keep records on actual water use; this information shall be submitted by June 1st of each year as an annual report to the Regional Water*”;

WHEREAS, the Regional Water Manager considers it desirable that the requirements for reporting of actual water use be amended;

WHEREAS I, Allan Chapman, am the Regional Water Manager empowered to make orders under sections 22 and 85(2) of the **Water Act** of British Columbia;

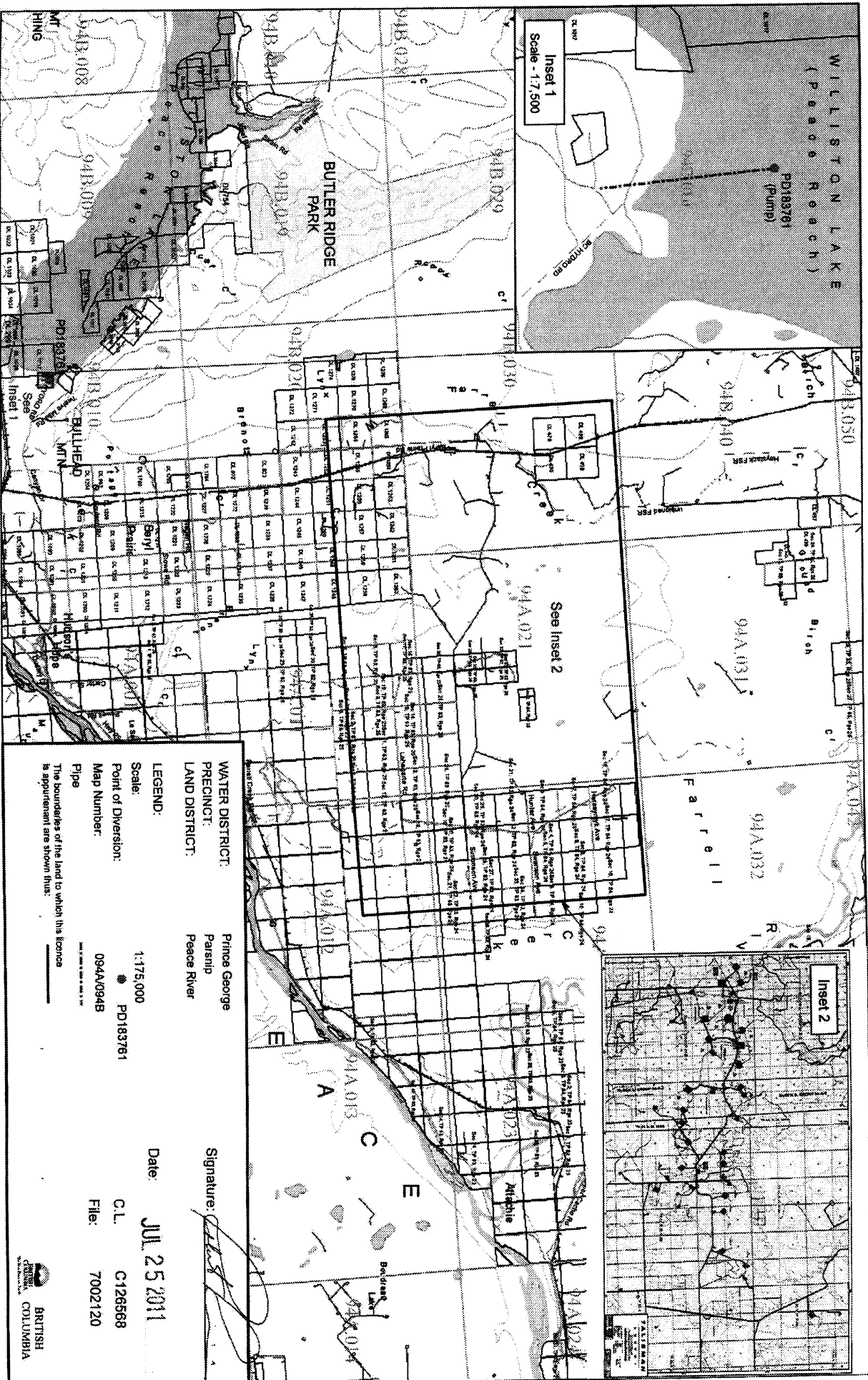
NOW THEREFORE, I HEREBY ORDER, that condition “k” in Conditional Water Licence C126568, held by Progress Energy Canada Ltd., be amended to the following:

This licensee shall keep records on actual daily water withdrawals in units of cubic metres. This information will be submitted to the Regional Water Manager on a quarter-annual basis, on or before January 25, April 25, July 25 and October 25, for the preceding 3 month period, in a digital comma separated value format. The requirement for water use reporting may be amended from time to time, as directed by the Regional Water Manager.
