#### CONDITIONAL WATER LICENCE

- e) The maximum quantity of water which may be diverted is 0.04526 cubic metres (100 gallons) per day.
- f) The period of the year during which the water may be used is April 1st to September 30th.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 3 District Lot 1319 Kamloops Division Yale District Plan 34175.
- h) The authorized works are screened intake, pump, pipe, standpipe and irrigation system which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2014. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.


