



Water Act

CONDITIONAL WATER LICENCE

The District of Summerland is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Okanagan Lake.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is October 22, 2003.
- d) The purpose for which this licence is issued is waterworks.
- e) The maximum quantity of water which may be diverted waterworks purpose is 3,460,000 cubic metres per year, and the maximum rate of diversion is 19,700 cubic metres per day.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is the boundaries of the Corporation of the District of Summerland.
- h) The authorized works are screened intake, pipe and pumps which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to 31st December 2014. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) The works authorized under clause (h) hereof shall be constructed to operate within a lake elevation of 340.41 to 343.09 metres (1116.8 to 1125.3 feet), Geodetic Survey of Canada datum.
- k) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- l) Works shall be installed to meter and record the rate of water diversion and the quantity of water diverted under this licence.

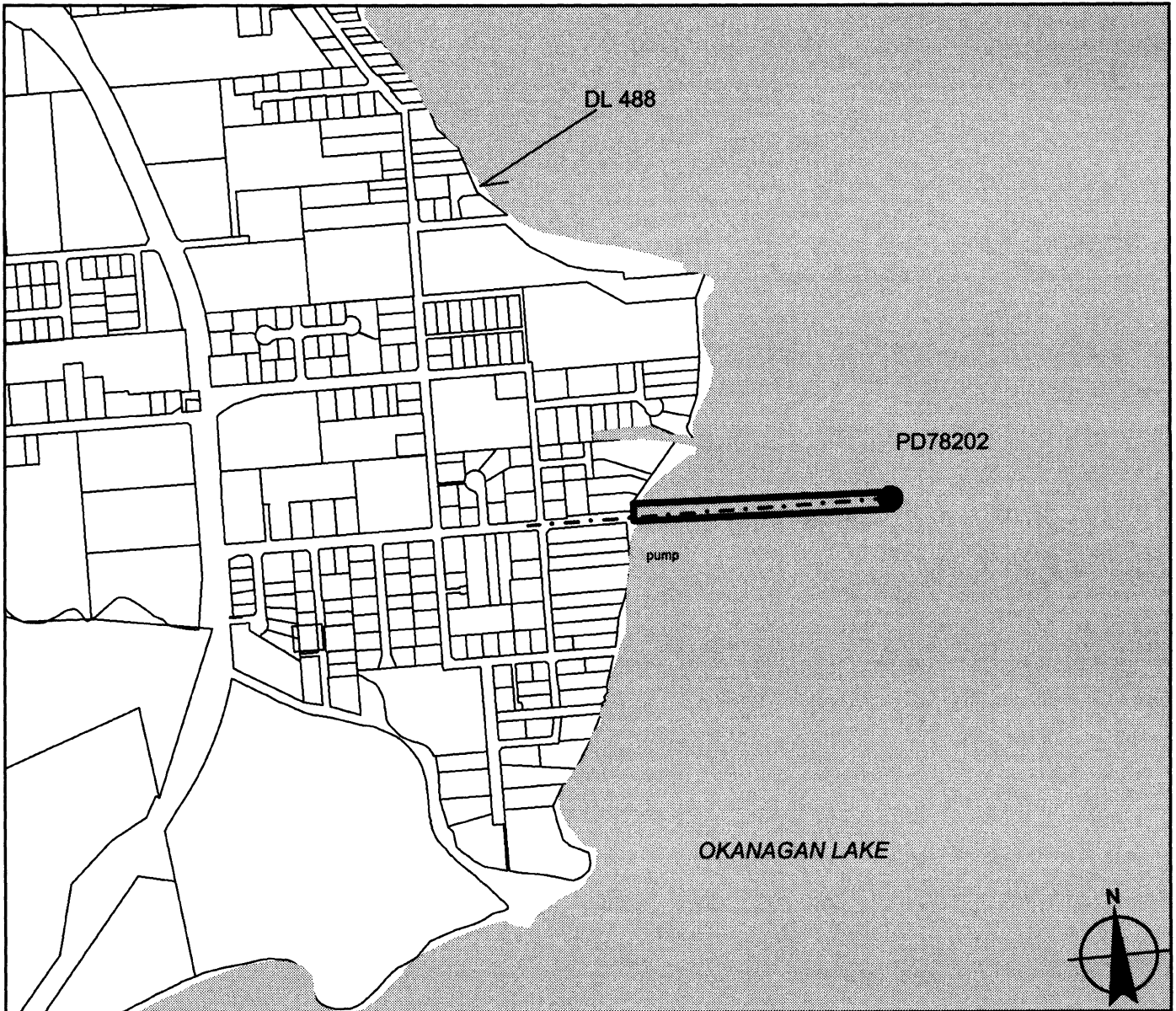
Having determined that the construction of said works has not been completed by this date, and being satisfied that no person's rights will be injuriously affected I hereby amend clause (i) of the said licence to read as follows:

- (i) The construction of the said works shall be completed and the water shall be beneficially used prior to the 31st day of December, 2017. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
