

Province of British Columbia Water Act

CONDITIONAL WATER LICENCE

The owners of the land to which this licence is appurtenant are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Summers Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is 20th September, 1919.
- d) The purpose for which this licence is issued is irrigation.
- e) The maximum quantity of water which may be diverted is 6,200 cubic meters (5 acre feet) per year.
- f) The period of the year during which the water may be used is 1st April to 30th September.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Lot 4 District Lot 3345, Kamloops Division Yale District, Plan KAP85381, of which 0.8 hectares (2 acres) may be irrigated.
- h) The authorized works are diversion structure, pump, pipe and irrigation system which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to 31st December, 2015. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This Licence is issued in substitution of Final Water Licence 6312, in part.

k) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

ORDER UNDER THE WATER ACT SECTION 18

File No. 8003093

In the matter of Conditional Water Licence C128713, which authorizes the diversion of water from Summers Creek for irrigation purpose within Lot 4 District Lot 3345 Kamloops Division Yale District, Plan KAP85381 of which 0.8 hectares (2 acres) acres may be irrigated.

Having determined that the licence includes storage on Missezula Lake, and being satisfied that no person's rights will be injuriously affected I hereby amend clauses (k) of the said licence to read as follows:

(k) Any water diverted and used pursuant to this licence during the period from April 1 to September 30, must be taken from storage provided in the reservoir authorized under Conditional Water Licence Number C131822 or any licence issued in substitution thereof.


