

Province of British Columbia Water Act

CONDITIONAL WATER LICENCE

The holder of a lease held under Lands file 3400826 to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Headwater Lakes (Reservoir 2).
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is May 26, 2009.
- d) The purpose for which this licence is issued is domestic.
- e) The maximum quantity of water which may be diverted is 0.68 cubic meters per day (150 gallons per day).
- f) The period of the year during which the water may be used is 1st May to 31st October.
- g) The land upon which the water is to be used and to which this licence is appurtenant is Block B of District Lot 2681, Kamloops Division of Yale District Lands File 3400826].
- h) The authorized works are pump, pipe and screened intake which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2015. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
- k) This licence does not authorize the diversion and use of water at any time when the water level of Headwater Lakes (Reservoir 2) falls below 30% of live storage volume. This equates to an elevation of 1230.1 meters (4035.6 feet).
- 1) This licence terminates on June 25, 2017. Prior to the termination date, the licensee may apply to amend this licence to extend its term.



- m) The licence holder is required to install a flow metering device to record the volume of water diverted under this licence. You will be required to submit in writing to the Assistant Regional Water Manager a record of total annual water use (cubic meters per year) by November 30th of each calendar year.
- n) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.

ORDER UNDER THE WATER SUSTAINABILITY ACT SECTION 26

File No. 8002857

In the matter of Conditional Water Licence C128815, which authorizes the diversion of water from Headwater Lakes (Reservoir 2) for domestic use within Block B District Lot 2681 Kamloops Division Yale District; and,

Having determined that the Crown lease upon which land the water is to be used and to which said licence is appurtenant has been renewed, and being satisfied that no person's rights will be injuriously affected I hereby amend clause (I) of the said licence to read as follows:

(1) This licence terminates on June 25, 2030. Prior to the termination date, the licensee may apply to amend this licence to extend its term.
