CONDITIONAL WATER LICENCE

The owner(s) of the land to which this licence is appurtenant is/are hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is White Lake.
- b) The points of diversion and re-diversion are located as shown on the attached plan.
- c) The date from which this licence shall have precedence is May 8, 2008.
- d) The purpose for which this licence is issued is domestic.
- e) The maximum quantity of water which may be diverted is 2.27 cubic metres per day.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is that part of Lot 2 Section 23 Township 22 Range 10 West of the 6th Meridian Kamloops Division Yale District Plan KAP92296 which is lying south of Parri Road.
- h) The authorized works are diversion structure, pump and pipe which shall be located approximately as shown on the attached plan.
- i) The construction of the said works shall be completed and the water shall be beneficially used prior to December 31, 2015. Thereafter, the licensee shall continue to make regular beneficial use of the water in the manner authorized herein.
- j) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- k) The rights granted herein are exercisable only during such times as the licensee remains a

member of the White Lake/White Creek Water Users' Community, and as long as works under Conditional Water Licence 105691, or any licence issued in substitution thereof, are being maintained and operated to the satisfaction of an Engineer under the Water Act.

- l) This licence does not authorize the diversion and use of water at any time when the water level of White Lake falls below 97.5 feet (29.718 metres) as shown on Drawing Number 1012.001 without written approval from the Regional Water Manager or an Engineer under the Water Act.
- m) Any water diverted and used pursuant to this licence must be taken from storage provided in the reservoir authorized under Conditional Water Licence 105691 or any licence issued in substitution thereof.
- n) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing of an Engineer under the Water Act, in order to maintain a minimum flow in the stream for the preservation of fish and other aquatic life.
- o) The licensee shall install a flow measuring device to the satisfaction of an Engineer under the Water Act.
- p) The licensee shall retain flow meter records for inspection upon request by an Engineer under the Water Act.
- q) This licence authorizes the use of water for domestic purpose in one dwelling located approximately as shown on the attached plan.
