CONDITIONAL WATER LICENCE

The holder of a Licence of Occupation held under Crown Land Tenure 2403166 to which this licence is appurtenant is hereby authorized to divert and use water as follows:

- a) The stream on which the rights are granted is Alpine Creek.
- b) The point of diversion is located as shown on the attached plan.
- c) The date from which this licence shall have precedence is February 26, 1987.
- d) The purpose for which this licence is issued is industrial (bottle sales).
- e) The maximum quantity of water which may be diverted for industrial (bottle sales) is 453.36349 cubic meters a day (36,400,000 gallons a year), provided that the maximum rate of diversion shall not exceed 0.0006135 cubic meters (1.3 cubic feet) per second.
- f) The period of the year during which the water may be used is the whole year.
- g) The land upon which the water is to be used and to which this licence is appurtenant is that unsurveyed foreshore or land covered by water being part of the bed of Toba Inlet, Range 1, Coast District, held under Lands File 2403166.
- h) The authorized works are screened intake, pipe, tank, mobile pump and loading facility which shall be located approximately as shown on the attached plan.
- i) The construction of the said works has been completed and the water is being used. The licensee shall continue to make regular beneficial use of the water in a manner authorized herein.
- j) The diversion of water authorized under this licence may be restricted or prohibited at any time by an Order in writing of an Engineer under the Water Act, in order to maintain a minimum flow in the stream for the preservation of fish and other aquatic life.
- k) The licensee shall provide a notarized annual report on the volume of water used during the preceeding calendar year, to the Regional Water Manager of the South Coast Region, Ministry of Forests, Lands and Natural Resource Operations.

- l) This licence is issued under the Water Act (the Act). The exercise of rights under the licence is subject to the Act and its regulations, the terms and conditions of the licence, orders under the Act and the rights of licensees whose rights have precedence on the stream. The licensee must comply with all such requirements, as well as the provisions of all other applicable enactments. In exercising rights under the licence, the licensee must exercise reasonable care to avoid damaging land, works, trees or other property, and must make full compensation to the owners for damage or loss resulting from construction, maintenance, use, operation or failure of the works.
- m) Where a Licence of Occupation on Crown Land is the appurtenancy of the water licence, said Licence of Occupation must remain in good standing and for the purpose for which the Licence of Occupation was originally issued. The licence may be subject to cancellation if a valid appurtenancy does not exist.
- n) The water diverted under this licence cannot be exported in bulk from British Columbia as per the requirements of the Water Protection Act.
- o) The water diverted under this licence must be bottled and packaged in British Columbia as per the requirements of the Water Protection Act.
- p) This Licence is issued in substitution of Conditional Water Licence C067564.
